HOME RULE CHARTER AMENDMENT

Section 6 of the Home Rule Charter of the City of Robbinsdale is hereby amended to read as follows:

"Section 6. Nominations. Any person desiring to become a candidate for mayor, alderman, assessor, justice of the peace or judge of the municipal court or special judge of the municipal court, as the case may be, shall, prior to the municipal election and conforming with state elections, file with the city clerk of the city a statement of such candidacy in substantially the following form as heretofore stated in Section 6".

HOME RULE CHARTER AMENDMENT

Section 65 of the Home Rule Charter of the City of Robbinsdale is hereby amended to read as follows:

"Section 65. Emergency Debt Certificates. If in any year the receipts of the city shall from some unforeseen cause become insufficient for the ordinary expenses of the city, or if any calamity or other public emergency should make necessary extraordinary expenditures, the council may by a resolution approved by all of the members thereof at a meeting due notice of which shall have been previously given in the official newspaper of the city, authorize the sale of emergency debt certificates to run not to exceed three years, and to bear interest at a rate of not more than six per cent per annum. A tax sufficient to redeem all such certificates at maturity shall be levied as part of the budget of the next two years following the issuance of such certificates."

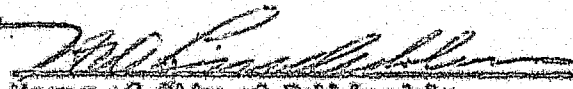

HOME RULE CHARTER AMENDMENT

Section 66 of the Home Rule Charter of the City of Robbinsdale is hereby amended by addition of Paragraph 6 as follows:

"(6) Obligations issued for the creation or the maintenance of the permanent improvement revolving fund."
