


NOTICE OF ELECTION FOR THE PROPOSED INCORPORATION OF
THE VILLAGE OF NIMROD

Notice is hereby given; That an election of the proposed incorporation of the Village of Nimrod, in the County of Wadena, State of Minnesota, will be held on Monday August 12, 1946, between the hours of Nine o'clock A. M. and Five o'clock P. M. at the Community Hall located on Lot 58 of Auditor's Plat of Nimrod Townsite, Orton Township, Wadena County, Minnesota. for the determination of the proposed incorporation.

Whereas a petition to the County Board of Wadena County, Minnesota, requesting said Board to call an election for the determination of the proposed incorporation of the Village of Nimrod, in the County of Wadena, State of Minnesota, has been filed with the County Board of Said County, as provided by Chapter 1111 Masons Minnesota Statutes of 1927, the area of the proposed incorporation of said Village of Nimrod shall be comprised of all of Section Thirty-two (32), Township One Hundred Thirty-seven (137) Range Thirty-three (33) and including that portion of said section as now platted as Auditor's Plat of Nimrod Townsite as recorded in the office of the Register of Deeds of Wadena County, Minnesota, in Book "B" of Plats on page 4;

Therefore be it resolved by the County Board of Wadena County, State of Minnesota, at the Regular session of said Board held on the 8th day of July 1946, That said petition be approved, that the date of said election be set to take place on the 12th day of August 1946, between the hours of Nine o'clock A. M. and Five o'clock P.M. and that said election be held in the Community Hall located on Lot 58 of Auditor's Plat of Nimrod Townsite, Orton Township, Wadena County, Minnesota, to determine the proposed incorporation and that Alfred Haugen, Ed Nielsen and John L. Stigman are hereby appointed Inspectors who will act as Judges of said election.



A PETITION TO THE COUNTY BOARD OF WADENA
COUNTY REQUESTING SAID BOARD TO CALL AN
ELECTION FOR THE DETERMINATION OF THE
PROPOSED INCORPORATION OF THE VILLAGE OF
NIMROD, IN THE COUNTY OF WADENA AND STATE
OF MINNESOTA.

To the Board of County Commissioners of
Wadena County, Minnesota:

We, the undersigned, voters and residents upon the land to be embraced in the proposed incorporated Village of Nimrod, Wadena County, Minnesota, and who have resided upon such land within the territory proposed to be incorporated for at least two years prior to the date of this Petition, hereby petition and request that an election be called for the determination of such proposed incorporation, and fixing the time and place when and where the voters actually residing upon such land may vote for or against such incorporation.

In support of this Petition, your petitioners hereby state:

I.

The name of the proposed village shall be "Nimrod", in the County of Wadena and State of Minnesota.

II.

That we have caused a census to be taken of the resident population within such territory, and such census is hereto attached, marked Exhibit "A", consisting of one page, and made a part hereof; that said census is found to contain more than the required number of residents, as provided by Section 412.02 of the Minnesota Statutes for 1941, to-wit: One Hundred Sixteen (116) people; that said census was taken under the direction of the Petitioners herein on and between May 17, 1946 and May 21, 1946.

III.

That the boundaries of the territory to be embraced in such proposed Village are as follows:

Commencing at the southwest corner of Section Thirty-two (32), in Township One Hundred Thirty-seven (137) North, of Range Thirty-three (33) West, in Wadena County, Minnesota, thence running north on the section line for a distance of one mile to the northwest corner of said Section Thirty-two (32); thence running east on the section line for a distance of one mile to the northeast corner of said Section Thirty-two (32); thence running south on the section line for a distance of one mile to the southeast corner of said Section Thirty-two (32); thence running west on the section line for a distance of one mile to the southwest corner of said Section Thirty-two (32), embracing all of said Section Thirty-two (32) in Township One Hundred Thirty-seven (137) North, of Range Thirty-three (33) West, which township is also known as Orton Township, Wadena County, Minnesota.

IV.

That part of the said territory so embraced has been platted into lots and blocks since December 19, 1944, and is duly recorded in the office of the Register of Deeds of Wadena County, Minnesota, in Book P of Plats on page 4, and is known as Auditor's Plat of Nimrod Townsite; and in addition to said lots and blocks, the

proposed village also embraces unplatted land adjacent to the platted portion, and such unplatted portions are so conditioned and so situated with reference to the proposed Village of Nimrod as properly to be subjected to village government.

V.

That attached hereto and made a part of this Petition is a plat of the territory proposed to be embraced in said village, and duly certified to by Elmer Howard, a land surveyor of Wadena County, Minnesota.
