

ORDINANCE # 69

AN ORDINANCE EXTENDING THE BOUNDARIES OF THE  
VILLAGE OF NORWOOD,  
CARVER COUNTY, MINNESOTA

The Village Council of the Village of Norwood do ordain  
as follows:

WHEREAS, the owners of the following described tract or  
parcel of land situate, lying and being in Carver County, Minn.  
and described as follows, to wit:

Commencing at the Northeast Corner of the Following  
tract or parcel of land lying and being in said Car-  
ver County, described as follows, to wit: Commenc-  
ing at a point on the Section line 33 feet South of  
the Southwest Corner of the Northwest Quarter of the  
Southwest Quarter of Section 14, Township 115, Range  
26, thence running East 144 feet, thence South paral-  
lel with the Section line between Sections 14 and 15  
367 4/10ths feet, thence West at right angles 144 ft.  
to aforesaid Section line, thence North along said  
Section line 367 4/10ths feet to the place of begin-  
ning, situated in Lot 1, Section 14 Township 115, Range  
26 and containing 1.22 acres; ~~thence West along the~~  
*120* North line of said tract or parcel of land a distance  
of ~~120~~ *120* feet to a point; thence South parallel with the  
East line of said tract or parcel of land a distance  
of 120 feet to a point; thence East parallel with the  
*120* North line of said tract or parcel of land a distance  
of ~~120~~ *120* feet to a point on the East line of said tract  
or parcel of land; thence North along the East line of  
said tract or parcel of land a distance of 120 feet to  
the place of beginning, all in Lot 1, Section 14 Town-  
ship 115, Range 26 Carver County, Minnesota, /

which said tract or parcel of land abuts upon said Village of  
Norwood and contains less than 200 acres of land, Have duly  
petitioned the Village Council of said Village of Norwood to  
extend the boundaries so as to include said tract or parcel of  
land, which said petition was duly granted by said Village of  
Norwood and the boundaries of said Village of Norwood are here-  
by extended so as to include said tract or parcel of land.
