ORDINANCE No. 41

AN ORDINANCE EXPANDING THE VILLAGE BOUNDARIES OF THE VILLAGE OF ROTHSAY, WILKIN COUNTY, MINNESOTA, TO INCLUDE WITHIN SAID VILLAGE CERTAIN LANDS SITUATED IN OTTER TAIL COUNTY, MINNESOTA, AND ABUTTING THE SAID VILLAGE OF ROTHSAY.

WHEREAS a Petition duly made and executed by a majority of the owners of certain platted and unplatted lands situated in Otter Tail County, Minnesota, and abutting the Village of Rothsay, Minnesota, have petitioned the Council of said Village to have such land included within the Village, and,

WHEREAS, the said lands constitute one contiguous tract or parcel not exceeding two hundred (200) acres in area and are so conditioned as properly to be subjected to Village government, and,

WHEREAS, the Village Council desires by Ordinance to so extend the Village boundaries as to include the same in accordance with the Statute in such case made and provided,

THE VILLAGE COUNCIL OF THE VILLAGE OF ROTHSAY DO ORDAIN AS FOLLOWS:

SECTION I. The Village boundaries of the Village of Rothsay, County of Wilkin, State of Minnesota, are hereby extended so as to include within the Village the following platted and unplatted land situated in the County of Otter Tail, State of Minnesota described as follows:

The Southwest Quarter of the Southwest Quarter (SW^{1/4} of SW^{1/4}) of Section Thirty (30), Township One Hundred Thirty-Five (135) North, Range Forty-Four (44) West and the West Sixteen and one-half (W 16 $\frac{1}{2}$) feet of the Southeast Quarter of the Southwest Quarter (SW^{1/4} of SW^{1/4}) of said Section Thirty (30), all of which foregoing described property is platted as Juvrud's Addition to Rothsay, Otter Tail County, Minnesota, and also that portion of the fractional Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ of NW $\frac{1}{4}$) also known as Government Lot One (1) of Section Thirty-One (31), Township One Hundred Thirty-five (135) North of Range Forty-four (44) West, described as follows: beginning at the highway stake in the Northwest corner of the Northwest Quarter (NW $\frac{1}{4}$) of Section Thirty-One, Township One Hundred Thirty-five (135) North of Range Forty-four (44) West, thence running Southeast and along the East side of trunk highway # 52 a distance of Four Hundred (400) feet, thence Northeast (NE) and at right angles to the said trunk highway a distance of one hundred twenty (120) feet, thence in a Northwesterly (NW) direction and parallel with the said trunk highway a distance of four hundred (400) feet, thence in a Southwesterly (SW) direction one hundred twenty (120) feet to the place of beginning, all of the above described parcel being in the Northwest corner of the Northwest Quarter (NW $\frac{1}{4}$) of said Section Thirty-one (31) and including within the extension of Village boundaries all of said trunk highway #52 lying and being to the West of said described parcel and within Otter Tail County,

and also that parcel of land described as follows:
Commencing at a point one hundred eighty-five (185) feet due East from the Northwest corner of the Northwest Quarter (NW $\frac{1}{4}$) of Section Thirty-one (31), Township One Hundred Thirty-five (135) North of Range Forty-four (44) West, Otter Tail County, Minnesota, thence due South eight (8) rods, thence due East ten (10) rods, thence due North eight (8) rods, thence due West ten (10) rods to the point of beginning.

SECTION II. The lands described above are declared to be a part of and included within the Village of Rothsay to all intents and purposes the same as though originally within the incorporated limits of said Village.

SECTION III. The Village Recorder of the Village of Rothsay shall file a certified copy of this Ordinance with the Secretary of State of the State of Minnesota in compliance with Section 413.08, Minnesota Statutes, 1941, and a like copy in the office of the Register of Deeds of Otter Tail County and Wilkin County, said State.

SECTION IV. This Ordinance shall be in full force and effect from and after its passage and publication according to law.

SECTION V. All Ordinances, Resolutions and parts of Ordinances in conflict with this Ordinance and its provisions are hereby repealed.
