#### PETITION FOR INCORPORATION OF VILLAGE

To the Board of County Commissioners of the  $C_{O}unty$  of Cass, Minnesota:

The undersigned 25 voters, who have resided in the territory hereinafter described for a period of at least two years prior to the date of this petition, hereby petition your honorable board to fix a time and place when and where the resident voters may vote on the proposition of incorporation of such territory as a village to be known by the name of Pine Beach Landing. The territory proposed to be incorporated is described as follows:

> Lot 4, Section 18, Lot 6, Section 19, All of Lots 1 to 19 inclusive, Pine Beach plat, Lots 1, 2, 3 and 4; Section 30, The  $SW_{4}^{-}$  of the  $NE_{4}^{-}$  and the  $SE_{4}^{-}$  of the  $NW_{4}^{-}$  and the  $SE_{4}^{-}$ , and the  $E_{2}^{+}$  of the  $SW_{4}^{-}$ , all in Section 30, That part of Lot 6, Section 29, deeded to E. 
