PETITION TO ESTABLISH A CITY OF THE FOURTH CLASS TO BE KNOWN AS THE CITY OF ARLINGTON.

TO THE COUNTY BOARD OF SIBLEY COUNTY, MINNESOTA:

The undersigned inhabitants of contiguous territory, not organized as a city and having a population of not less than one thousand inhabitants and not more than ten thousand inhabitants who are qualified to vote within the territory herein, designated as the territory proposed to be incorporated as a City of the fourth class, do hereby petition your Honorable Board to establish a City of the Fourth Class, and to call a special election to determine whether or not a city of the fourth class shall be established in the following described territory, all situated in Sibley County, to-wit:

Commencing at a point 1124.2 feet North and 33 feet East of the West quarter corner of Section 9 in Township 113, Range 27 West, Sibley County, Minnesota, which point is the NW corner of the Sibley County fair grounds; thence running East 110 feet; thence South 323 feet; thence East 1560.4 feet to the East boundary line of State Trunk Highway No. 5; thence continuing North 85 degrees East 2114 feet to a point in the center of High Island Creek; thence following the center of High Island Creek in a Southerly and Easterly direction approximately 700 feet to the center of the bridge on County Aid Road No.1, said bridge being approximately 874 feet North of the East quarter corner of said Section 9; thence running due East 555 feet; thence South 874 feet to the present North boundary line of the Village of Arlington; thence due East on the present North boundary line of the Village of Arlington 579.34 feet to the Northeast corner of the Village of Arlington; thence South 1492 feet; thence West 579.34 feet; thence South 1148 feet; thence West 1872.3 feet; thence North 650 feet; thence West 3967.2 feet to a point of intersection with the East boundary line of the public highway now located on the West line of said section 9; thence North on the East boundary line of said highway 3125 feet to the point of beginning.

And your petitioners pray that said territory be divided into two wards, numbered 1 and 2,-ward No.1 to consist of the following described territory, to-wit:

Commencing at the center of Main Street on the east boundary line of the Village of Arlington in Sibley County, Minn.; thence running South on said East boundary line 300 feet more or less to the Southeast corner of the Arlington Public Cemetery grounds, thence running West 579.34 feet; thence South 1148 feet; thence West 1872.3 feet; thence North 652 feet; thence West 3967.2 feet to the point of intersection with the East boundary line of the public highway now located on the West line of Section 9, Township 113. Range 27 West; thence North on the East boundary line of said highway approximately 1350 feet to the center line of Main Street in the said Village of Arlington extended due West to intersect the West boundary line of said Section Nine (9); thence East on the center line of Main Street in said Village extended 6418.84 feet more or less to place of beginning. Said Ward Number 1 shall include all territory South of Main Street in said Village of Arlington extended.

Said Ward No. 2 to consist of the following described territory, to-wit:

Commencing at a point 1124.2 feet North and 33 feet East of the West Quarter corner of Section 9 in Township 113, Range 27 West, Sibley County Minnesota, which point is the Northwest corner of the Sibley County Fair grounds; thence running East 1110 feet; thence South 323 feet; thence East 1560.4 feet to the East boundary line of State Trunk Highway No.5; thence continuing North 85 degrees East 2,114 feet to a point in the center of High Island Creek; thence following the center of High Island Creek in a Southerly and Westerly direction approximately 700 feet to the center of the Bridge on County Aid Road No.1, said bridge being approximately 874 feet North of the East quarter corner of said Section 9; thence running due East 555 feet; thence South 874 feet to the present North boundary line of the Village of Arlington; thence due East on the present North boundary line of the Village of Arlington 579.34 feet to the Northeast corner of the Village of Arlington; thence South on the East boundary line of said Village of Arlington 625 feet more or less to the center line of Main Street in said Village; thence West on the center line of Main Street in the Village of Arlington extended to the West boundary line of Section 9 in said Township; thence West on the center of Main Street in said village 6418.84 feet more or less to a point of intersection with the East boundary line of the public Highway now located on the West line of said Section 9; thence North on the East boundary line of said highway 1800 feet more or less to the point of beginning; said Ward No.2 to consist of all territory lying North of the center of Main Street in said Village of Arlington extended.

In support of said petition your petitioners state and represent that there are 1195 inhabitants in said above described territory and that 590 voters voted in said territory at the last general election for State officers, and that the residence of each signer on this petition is correctly stated opposite his signature.

WHEREFORE, your petitioners pray that a city of the fourth class, to be known as the City of Arlington, be established in said above described territory and that a special election be called to determine whether or not such city shall be incorporated as the City of Arlington, and that a resolution be adopted approving this petition, and that the time and place of holding such special election be designated in said resolution and specifying the location of the polling place in each ward all as provided in Section 1828-17 Mason's Statutes 1940 Supplement.
