Petition

TO THE BOARD OF COUNTY COMMISSIONERS IN AND FOR MORRISON
COUNTY, MINNESOTA

We, the undersigned electors and resident voters who have for more than two years continuously resided upon the land hereinafter described to wit: Lot 1 to 6 both inclusive in Block 1, Original Townsite of Elmdale, Morrison County, Minnesota, and all of the other adjacent land in Section 5, all of Section 6, 7, N.E. $\frac{1}{4}$, N $\frac{1}{2}$ of the S.E. $\frac{1}{4}$, N $\frac{1}{2}$ of the N.W. $\frac{1}{4}$ and S.E. $\frac{1}{4}$ of the N.W. $\frac{1}{4}$ of Section 8 all in Township 127, Range 30 N. Morrison County, Minnesota, respectfully request the Board of County Commissioners to appoint and designate a time and place, when and where the electors actually residing upon said real estate may vote for or against the incorporation of all of said territory into a Village to be known as the "Village of Elmdale", in County of Morrison, State of Minnesota. The real estate to be included within the corporate limits of said Village to be known as the "Village of Elmdale" being more particularly described as follows:

All of Section 5, including Lots one to six both inclusive in Block one, Original Townsite of Elmdale according to the Plat thereof on file and of record in the Office of the Register of Deeds, Section six, seven, and N.E. $\frac{1}{4}$, N $\frac{1}{2}$ of the S.E. $\frac{1}{4}$, N $\frac{1}{2}$ of the N.W. $\frac{1}{4}$ and S.E. $\frac{1}{4}$ of the N.W. $\frac{1}{4}$ of Section 8 all in Township 127, Range 30 N. containing 2280 acres more or less, according to the United States Government Survey thereto, in County of Morrison, State of Minnesota.

That there are actually residing within said described territory one hundred and twenty-one (121) persons which number has been duly ascertained by your petitioners by a census taken of the residents population on the 15th. day of March, 1947, which date was not more than eight weeks previous to the presentation of this petition to the

Board of County Commissioner of said County.

That the herein before described real estate is not within the limits of any incorporated city or Village in said County of Morrison County, State of Minnesota.

That a parcel of the hereinbefore described real estate has heretofore been plated into lots and blocks, which plat has been heretofore duly certified according to the Laws of the State, filed and recorded in the Office of the Register of Deeds in and for Morrison County, Minnesota, as provided by law: that said plated portion of the land adjoins the other lands which is proposed to be incorporated.

That residing on the heretofore described real estate are at least one hundred and twenty one (121) persons as will more fully appear by the report of the census heretofore taken of the inhabitants actually residing within the described territory, hereto attached and made a part of this petition.

That the undersigned petitioners and resident electors resided upon said real estate hereintofore described which is proposed to be incorporated into a Village known as the "Village of Elmdale" in the County of Morrison, State of Minnesota.

That the undersigned petitioners are voters who have resided within the described territory continuously for a period at least two years prior to the date of the signing of this petition.
