

PETITION TO INCORPORATE THE COMMUNITY OF URBANK
AND IMMEDIATE VICINITY IN
OTTER TAIL COUNTY, MINNESOTA

TO: THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF OTTER TAIL AND STATE
OF MINNESOTA.

Gentlemen:

Your petitioners respectfully represent and show to your honorable body:

I.

The undersigned, consisting of twenty-five or more of the voters who have resided within the territory hereinafter described continuously for a period of at least two years prior to the date of this petition respectfully request of your honorable body to call an election for the determination of the incorporation of the present village of Urbank, which has a platted portion, and surrounding vicinity, the boundaries of said territory being as follows to-wit:

Beginning at the Northeast corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 30, Township 131, Range 38; thence due West along the quarter-section line to the Northwest corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ in said Section 30, thence South along the 40-line to the Northeast corner of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ in said Section 30, thence West along the 40-line to the Northwest corner of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ in said Section 30, thence South along the section line to the Southwest corner of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ in Section 31, said township and range, thence East along the 40-line to the Southeast corner of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ in said Section 31, thence North along the section line to the place of beginning.

II.

That the number of actual residents of said territory hereinbefore described, at the date of this petition, is One Hundred Forty-two (142).

III.

That the proposed name of the Village is Urbank. That none of the above described real estate is in any incorporated village in said state of Minnesota. That some of the above described land is platted into lots and blocks and all of said platted portion is surrounded by the unplatted portion. That plat, or plats, of the platted portion has been duly and legally certified according to the laws of the State of Minnesota and filed in the office of the Register of Deeds for the County of Otter Tail and State of Minnesota. That the unplatted part of the territory herein described adjoins the platted portions and so conditioned as properly to be subject to village government. That all of said territory has a natural connection and the people residing therein have such a community of interest that the whole may be properly subject to village government.

That the census was taken of the above described territory on June 11, 1947, and the people who were actual residents therein of said territory on said date were one hundred forty-two (142) and the said census is within the number specified in section 412.02 of Minnesota Statute for 1945.

The undersigned petitioners are all desirous of incorporating said territory under the laws of the State of Minnesota applicable to the incorporation of villages.

WHEREFORE, Your petitioners pray that the County Board approve this within petition for the organization of the Village of Urbank pursuant to statute, and that said Board proceed forthwith to cause a copy of this petition, with notice attached fixing time and place for holding an election, said posting to be in three public places within the boundaries above described; and that time of the holding of said election be not less than twenty (20) or more than thirty (30) days after such posting; and the place of said election to be within the limits of the proposed village and to do all other things required by law as more fully set out in Sections 412.02 through 412.07 and such other laws applicable thereto of Minnesota Statute for 1945.
