KNOW ALL MEN BY THESE PRESENTS That I, J. A. A. Burnquist, Attorney General of the State of Minnesota, by virtue of the authority vested in me by law, do hereby constitute and appoint JAMES G. NYE of Duluth, Minnesota, to act without compensation as Special Assistant Attorney General for the state in the matter of bringing such actions to determine adverse title or proceedings in registration of titles as may be necessary to determine that the State of Minnesota is the owner in fee simple, free and clear of encumbrances, of the lands located in St. Louis County, Minnesota, described with the taconite leases from the state thereon as follows:

The Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of Section Fourteen (14), Township Fifty-nine (59), Range Fourteen (14).

The North Half of the Southwest Quarter (N $\frac{1}{2}$  of SW $\frac{1}{4}$ ), the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$  of SE $\frac{1}{4}$ ), and the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$  of NE $\frac{1}{4}$ ), all in Section Fifteen (15), Township Fifty-nine (59), Range Fourteen (14).

The Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$  of SW $\frac{1}{4}$ ), and the South Half of the Southeast Quarter (S $\frac{1}{2}$  of SE $\frac{1}{4}$ ), all in Section Thirteen (13), Township Fifty-nine (59), Range Fifteen (15).

The South Half of the Northwest Quarter (S $\frac{1}{2}$  of NW $\frac{1}{4}$ ) of Section Twenty-three (23), Township Fifty-nine (59), Range Fifteen (15).

The Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section Twenty-three (23), Township Fifty-nine (59), Range Fifteen (15).

The Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Twenty-four (24), Township Fifty-nine (59), Range Fifteen (15).


The Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section Thirty-four (34), Township Fifty-nine (59), Range Fifteen (15).

The Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) and the West Half of the Southeast Quarter (W $\frac{1}{2}$  of SE $\frac{1}{4}$ ), all in Section Twenty-eight (28), Township Fifty-nine (59), Range Seventeen (17).

The South Half of the Northwest Quarter ( $S\frac{1}{2}$  of  $NW\frac{1}{4}$ )  
of Section Thirty-three (33), Township Fifty-nine  
(59), Range Seventeen (17).


The North Half of the Southwest Quarter ( $N\frac{1}{2}$  of  $SW\frac{1}{4}$ )




