## ORDINANCE NO. 187

AN ORDINANCE TO ANGEL OSETAIN TERRITORY TO THE CITY OF LORININGTON, NINEESDYA.

THE CITY COUNCIL OF THE CITY OF PARTHE GTON DO ORDAIN:

NOW NUMBERS, Pursuant to Section 1843 et see of Mason's l'innesota Statutes of 1927, being Section 413.14 of the Minnesota Statutes for 1941, all the owners of the property hereinafter described and abutting upon the City of Worthington, have patitioned the City Council of said City of Worthington to have such property annexed to said City:
