return thereof on file herein, and the matter having come duly on  
for trial at a Special Term of the above named court held in the  
Court House in the city of Stillwater, County of Washington, State  
of Minnesota, on Monday, the 8th day of December, 1947, at which time  
all of the above named respondents appeared and were present in  
court, and the evidence having been duly submitted, and the court  
upon full advices having duly made and filed its findings of fact,  
conclusions of law, and having ordered the judgment and decree of  
this court,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

1. That said pretended village of Withrow and all thereof is  
not a legal village within the terms and contemplation of the  
Minnesota Statutes in such case made and provided.
2. That the defendants herein and each of them are holding  
office in said pretended village without legal authority.
3. That said village of Withrow cease to function or attempt to

function as a legal village, and that all proceedings therewith associated be and they hereby are declared null and void and of no effect.

4. That the defendants and each of them forthwith cease to assume and pretend to act as officers of said pretended village.
