

Be it ordained by the Village of Preston as follows:

Section 1. The village boundaries of the Village of Preston, Fillmore County, Minnesota, are hereby extended to include the following described real estate, viz:

Beginning at the intersection of the south line of the northwest quarter of the northwest quarter of section 5, township 102 north of range 10 west, and the most westerly point therein of the center of the main channel of the Root River, thence continuing along the center of the main channel of the Root River, first in a southerly direction and then in a northeasterly direction until the center of said main channel of the Root River again intersects the south line of the northwest quarter of the northwest quarter of said section 5; thence westerly along said south line of the northwest quarter of the northwest quarter of said section 5 to point of beginning; also beginning at the northwest corner of the southwest quarter of the northwest quarter of said section 5, thence south 110 feet, thence south 54 degrees and 15 minutes east 146 feet, thence south 82 degrees east 258 feet, thence north 233 feet, thence west 375 feet to place of beginning. Also: beginning at a point where the southerly boundary of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company right of way crosses the west line of the northeast quarter of the northwest quarter of section 5, township 102 north of range 10 west, thence following said boundary of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company right of way in a southeasterly direction to its intersection with the center line of the main channel of the Root River, thence southwesterly along the center line of the main channel of the Root River to its intersection with the west line of the northeast quarter of the northwest quarter of said section 5, thence north to place of beginning; also all that portion of the northwest quarter of the northwest quarter of section 5, township 102 north of range 10 west lying south of U. S. Highway Number 52, excepting therefrom a parcel described as beginning at the northwest corner of the northwest quarter of said section 5, thence east 526 feet, thence south 872 feet, thence westerly along the right-of-way of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company to the section line between sections 5 and 6 in said township and range, thence north 732 feet to place of beginning, and excepting therefrom a parcel described as all that portion of the northwest quarter of the northwest quarter of said section 5 lying and being south and east of the center of the main channel of the Root River.

Affidavit of Publication

ORDINANCE NO. 98

Be it ordained by the Village of Preston as follows:

Section 1. The village boundaries of the Village of Preston, Fillmore County, Minnesota, are hereby extended to include the following described real estate, viz:

Beginning at the intersection of the south line of the northwest quarter of the northwest quarter of section 5, township 102 north of range 10 west, and the most westerly point therein of the center of the main channel of the Root River, thence continuing along the center of the main channel of the Root River, first in a southerly direction and then in a northeasterly direction until the center of said main channel of the Root River again intersects the south line of the northwest quarter of the northwest quarter of said section 5; thence westerly along said south line of the northwest quarter of said section 5 to point of beginning; also beginning at the northwest corner of the southwest quarter of the northwest quarter of said section 5, thence south 110 feet, thence south 54 degrees and 15 minutes east 146 feet, thence south 82 degrees east 258 feet, thence north 233 feet, thence west 375 feet to place of beginning.

Also: beginning at a point where the southerly boundary of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company right-of-way crosses the west line of the northeast quarter of the northwest quarter of section 5, township 102 north of range 10 west, thence following said boundary of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company right-of-way in a southeasterly direction to its intersection with the center line of the main channel of the Root River, thence southwesterly along the center line of the main channel of the Root River to its intersection with the west line of the northeast quarter of the northwest quarter of said section 5, thence north to place of beginning; also all that portion of the northwest quarter of the northwest quarter of section 5, township 102 north of range 10 west lying south of U. S. Highway Number 52, excepting therefrom a parcel described as beginning at the northwest corner of the northwest quarter of said section 5, thence east 526 feet, thence south 872 feet, thence westerly along the right-of-way of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company to the section line between sections 5 and 6 in said township and range, thence north 732 feet to place of beginning, and excepting therefrom a parcel described as all that portion of the northwest quarter of the northwest quarter of said section 5 lying and being south and east of the center of the main channel of the Root River.
