My dear Secretary of State,

I have to acknowledge the receipt of your letter of 7th January and note the particulars you require to complete your records.

As far as I myself am concerned I have to report that I took charge of this consulate on the 31st October, 1947, and I enclose a certificate to this effect which I trust you will be able to accept pending the arrival of my King's Commission which is usually received only several months after the arrival of the incumbent at his post. It is first presented to the Federal Authorities at Washington who issue an execuatur after which both these papers are sent to me. As soon as they are received, I shall forward them to you for your information and such action as you may consider to be necessary.
