CONCERN:


WHEREAS a vacancy now exists in the office of state senator  
from the Forty-seventh Senatorial District of the State of Minnesota,  
caused by the death of the late state senator, the Honorable C. L.  
Cole; and

WHEREAS there will be occasion for the person elected to fill  
said vacancy to take office and to exercise the functions thereof at  
the next regular session of the state legislature;


NOW, THEREFORE, I, Luther W. Youngdahl, as Governor of the  
State of Minnesota, acting under the authority and direction of  
Section 17 of Article IV of the Constitution of this state, and the  
statutes in such case made and provided, do hereby direct that said  
vacancy shall be filled at the next general election on Tuesday, the  
2nd day of November, 1948; that candidates for said vacancy shall be  
nominated at the regular primary election to be held on Tuesday, the


14th day of September, 1948; that affidavits of candidacy for nomination at said primary be filed within the time prescribed by law for the regular primary election, to-wit, not later than the 5th day of August, 1948; that notices of said elections, the nomination and election of candidates, and the conduct of said elections be had, and all things pertaining thereto be done, as provided in Sections 205.05 to 205.17, Minnesota Statutes 1945, and other applicable provisions of law.

IN WITNESS WHEREOF I have hereunto caused the great seal of the state to be affixed and have hereunto set my hand at the Capitol in the City of Saint Paul, Minnesota, this 16 day of March, 1948.
