TO THE HONORABLE BOARD OF COUNTY COMMISSIONERS OF THE
COUNTY OF ST. LOUIS, STATE OF MINNESOTA:

Gentlemen:-

WE, THE UNDERSIGNED, Legal voters and residents within the territory and upon the lands described herein, do hereby petition your Honorable Board to call an election for the determination of the incorporation of the proposed Village of Kittzville, the said proposed village and incorporation to include the following lands and territories: The Northeast Quarter of the Northeast Quarter (NE 1/4 of NE 1/4) of Section Five (5), Township Fifty-seven (57), Range Twenty (20) West, etc.; the Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) of Section Four (4), Township Fifty-seven (57), Range Twenty (20) West, etc.; the Southwest Quarter of the Southwest Quarter (SW 1/4 of SW 1/4) of Section Thirty-three (33), Township Fifty-eight (58), Range Twenty (20) West, etc.; and the southeast quarter of the Southeast Quarter (SE 1/4 of SE 1/4) of Section Thirty-two (32), Township Fifty-eight (58), Range Twenty (20) West, etc.; all in St. Louis County, Minnesota.

Your petitioners have caused to be taken on the 15th day of May, 1912, an accurate census of the population of said territory proposed to be included in said Village and in said incorporation, which census was taken by Andrew Rand, Marco Marolt and Tony Ross, legal voters and residents on the lands and within the territory above described, and to be included within the proposed incorporation, and the persons so taking said census are among the petitioners whose signatures as are hereto attached. That a statement of said census so taken, as aforesaid, setting forth accurately the names of the inhabitants, actual residents, of the lands and territory above described, is hereto attached, marked "Exhibit A", and made a part hereof.

The boundaries of the territory proposed to be incorporated as said village are as above set forth and the quantity of the lands embraced therein is One Hundred Sixty (160) Acres. That the said lands include Thirty-nine and twenty-five hundredths (39.25) acres of platted lands, so called. That said platted lands have been duly platted into lots and blocks, as the townsite of Kittzville, and said plat has been duly and legally certified, according to the laws of the State of Minnesota and filed in the office of the Register of Deeds in and for said St. Louis County. That all of said lands lie in said St. Louis County.

That the lands above referred to as platted lands are as follows: The Northeast Quarter of the Northeast Quarter (NE 1/4 of NE 1/4) of Section Five (5), Township Fifty-seven (57), Range Twenty (20) West, etc. Beginning at the Iron Monument which marks the Northwest corner of the Northeast Quarter of the Northeast Quarter (NE 1/4 of NE 1/4) of Section Five (5), Township Fifty-seven (57), Range Twenty (20) West, etc.; thence running along the north boundary of said Section Five to the Iron Monument which marks the Northeast corner of said Section Five (5); thence south along the eastern boundary of said Section Five (5) to the Iron Monument which marks the Southeast corner of said Northeast Quarter of the Northeast Quarter (NE 1/4 of NE 1/4) of said Section Five (5); thence west to the Iron Monument which marks the Southwest corner of the said Northeast Quarter of the Northeast Quarter (NE 1/4 of NE 1/4) of said Section Five (5); thence north to the place of beginning. That said platted portion contains in all Thirty-nine and twenty-five hundredths (39.25) acres. That the unplatted portion of the territory hereinabove described and proposed to be included in said incorporation, adjoins the platted portion thereof above described and is so conditioned as properly to be subject to village government.

That the number of actual residents on all of the territory above described proposed to be included in said village incorporation, is four hundred six (406). That the resident population of all of the said territory so proposed to be incorporated, is not more than three thousand nor

less than two hundred, and the resident population of said platted portion thereof is not more than three thousand nor less than two hundred. That none of the lands or territory above described are already incorporated nor is any part thereof within the limits of any incorporated city, village or borough.

That the nucleus of the population of said lands and territory proposed to be incorporated as a village, is on or near the platted lands above described.

That the undersigned petitioners are all actual residents and voters of said territory.

That the name of said proposed village is Kittzville.

WHEREFORE, Your petitioners ask that your Honorable Board proceed according to law to call an election for the determination of such proposed incorporation of said Village of Kittzville, and that you take all the steps and proceedings required by law for such purpose.

RESOLUTION OF COUNTY BOARD.

WHEREAS a certain petition for incorporating the Village of Kitzville has been duly presented to the Board of County Commissioners in and for St. Louis County, State of Minnesota, in which said petition it is shown that it is desired to incorporate certain tracts of land in said county not already incorporated as a village, to-wit:

The Northeast Quarter of the Northeast Quarter (NE 1/4 of NE 1/4) of Section Five (5), Township Fifty-seven (57), Range Twenty (20) West, etc.; the Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) of Section Four (4), Township Fifty-seven (57), Range Twenty (20) West, etc.; the Southwest Quarter of the Southwest Quarter (SW 1/4 of SW 1/4) of Section Thirty-three (33), Township Fifty-eight (58), Range Twenty (20) West, etc.; and the Southeast Quarter of the Southeast Quarter (SE 1/4 of SE 1/4) of Section Thirty-two (32), Township Fifty-eight (58), Range Twenty (20) West, etc.; all in St. Louis County, Minnesota, a portion of which territory has been platted into lots and blocks, which said plat has been duly certified according to the laws of the State of Minnesota, and is duly filed in the office of the Register of Deeds in and for said County, to-wit:

Yahrmatter, residents of said territory be and they are hereby appointed Inspectors who shall act as judges of said election and shall conduct the same as far as practicable according to the laws regulating the election of Town Officers, and that the County Auditor in and for the said County of St. Louis be and he is hereby is directed to cause proper copies of said petition to be made and the same to be posted in three public places within the boundaries of the territory described in said petition and proposed to be incorporated, together with a notice attached to each of said copies, which said notice shall state the time and place of holding said election, pursuant to the determination of the Board of County Commissioners as to said time and place made by this resolution.

Commissioner Overton moved the adoption of the resolution and it was declared adopted upon the following vote: Yeas, -Commissioners Fraser, Tischer, Cumming, Overton and Ryan and Chairman McInnis, -6; Nays, - none.
