AN ORDINANCE EXTENDING THE VILLAGE BOUNDARIES

The Village Council of the Village of Foley do ordain as follows:

Section 1. That the village boundaries of the Village of Foley are hereby extended so as to include the following described land, located in Auditor's Subdivision of a part of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section Twenty-six (26), Township Thirty-seven (37), Range Twenty-nine (29), Benton County, Minnesota, abutting upon said village and of record in the names of Max Dumonceaux and Mary Dumonceaux, his wife, to-wit:

The West Ninety feet (W 90 ft.) of the East 140 feet (E 140 ft) of the North Half (N $\frac{1}{2}$ ) of Lot Six (6) and the West Ninety feet (W 90 ft) of the East 140 feet (E 140 ft) of the South Twenty and one-half feet (S 20.5 ft) of Lot Five (5);

and of record in the names of Gunder Ness and Gertrude Ness, his wife, to-wit:

The West Sixty-nine feet (W 69 ft) of the North Half (N $\frac{1}{2}$ ) of Lot Six (6) and the West Sixty-nine feet (W 69 ft) of the South Twenty and one-half feet (S 20.5 ft) of Lot Five (5);

and of record in the names of Sylvester Mechavich and Rosa Mechavich, his wife, to-wit:

The South Half of Lot Six (6);

and the following described land which has been deeded to the Village by the owners of the above described parcels of land for public street purposes and which is hereby incorporated into the village limits as a public street, being a continuation of an existing public street, to-wit:

A strip of land thirty-three feet (33 ft) in width described as follows: Beginning at a point on the east line of said Lot Six (6) and 137.5 feet south of the northeast corner thereof, which point is on the south line of an existing street in F. G. Smith's Subdivision to the Village of Foley; thence westerly and 2 degrees 25 minutes (2° 25') to right of said south street line produced, a distance of 209.0 feet to intersect with the easterly line of First Avenue West; thence north along said easterly line of First Avenue West a distance of thirty-three feet (33 ft); thence easterly a distance of 209 feet; thence south a distance of thirty-three feet (33 ft) to the point of beginning;

AN ORDINANCE EXTENDING THE VILLAGE BOUNDARIES

The Village Council of the Village of Foley do ordain as follows:

Section 1. That the village boundaries of the Village of Foley are hereby extended so as to include the following described land, located in Auditor's Subdivision of a part of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section Twenty-six (26), Township Thirty-seven (37), Range Twenty-nine (29), Benton County, Minnesota, abutting upon said village and of record in the names of Max Dumonceaux and Mary Dumonceaux, his wife, to-wit:

The West Ninety feet (W 90 ft.) of the East 140 feet (E 140 ft.) of the North Half (N $\frac{1}{2}$ ) of Lot Six (6) and the West Ninety feet (W 90 ft) of the East 140 feet (E 140 ft) of the South Twenty and one-half feet (S 20.5 ft) of Lot Five (5);

and of record in the names of Gunder Ness and Gertrude Ness, his wife, to-wit:

The West Sixty-nine feet (W 69 ft) of the North Half (N $\frac{1}{2}$ ) of Lot Six (6) and the West Sixty-nine feet (W 69 ft) of the South Twenty and one-half feet (S 20.5 ft) of Lot Five (5);

and of record in the name of Sylvester Mechavich and Rose Mechavich, his wife, to-wit:

The South Half (S $\frac{1}{2}$ ) of Lot Six (6);

and the following described land which has been deeded to the Village by the owners of the above described parcels of land for public street purposes and which is hereby incorporated into the village limits as a public street, being a continuation of an existing public street, to-wit:

A strip of land Thirty-three feet (33 ft) in width described as follows: Beginning at a point on the east line of said Lot Six (6) and 137.5 feet south of the northeast corner thereof, which point is on the south line of an existing street in F. G. Smith's Subdivision to the Village of Foley; thence westerly and 2 degrees 25 minutes (2° 25') to right of said south street line produced, a distance of 209.0 feet to intersect with the easterly line of First Avenue West; thence north along said easterly line of First Avenue West a distance of Thirty-three feet (33 ft); thence easterly a distance of 209 feet; thence south a distance of thirty-three feet (33 ft) to the point of beginning;
