

ORDINANCE # 71

AN ORDINANCE EXTENDING THE BOUNDARIES  
OF THE VILLAGE OF NORWOOD, CARVER  
COUNTY, MINNESOTA

The Village Council of the Village of Norwood do ordain  
as follows:

WHEREAS, the owners of the following described tract or  
parcel of land situate, lying and being in Carver County, Minn.,  
and described as follows, to wit:

Commencing at a point 33 feet South and 237 feet East  
of the Southwest corner of the Northwest Quarter of the  
Southwest Quarter of Section 14, Township 115 North of  
Range 26 West; thence South 270 feet parallel with Sec-  
tion line between Sections 14 and 15; thence west 60 feet  
at right angles thence North 270 feet parallel with said  
Section line; thence East 60 feet to the place of beginning  
situated in Lot one (1) Section 14-115-26.

Containing 37/100 acres, more or less

Commencing at a point thirty three (33) feet South and one  
hundred forty four (144) feet East of the Southwest corner  
of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$  of SW $\frac{1}{4}$ )  
of Section 14, Township 115 North of Range 26, West, thence  
running East thirty three (33) feet; thence South parallel  
with Section line between Sections 14 and 15 270 feet; thence  
East 60 feet; thence South 97 and 4/10ths feet; thence west  
at right angles 93 feet; thence North 367 and 4/10ths feet  
to place of beginning, all of it being situated in Lot 1 of  
Section 14, Township 115 Range 26 West, containing 41/100  
acres of land more or less.

which said tract or parcel of land abuts upon said Village of Nor-  
wood and contains less than 200 acres of land, have duly petitioned  
the Village Council of said Village of Norwood to extend the  
boundaries so as to include said tract or parcel of land, which  
said petition was duly granted by said Village of Norwood and the  
boundaries of said Village of Norwood are hereby extended so as to  
include said tract or parcel of land.
