

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

Section 1. Pursuant to a petition duly signed by all the owners of the following described land abutting upon the city limits of the City of Staples, and which land has been platted in lots and blocks, and which land is described as follows, to-wit:

Lots Sixty-one (61) and Sixty-two (62) of Auditor's Subdivision of the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section Twelve (12), Township One Hundred Thirty-three (133) North, of Range Thirty-three (33) West of the Fifth Principal Meridian.

which premises are also described by metes and bounds as follows:

Commencing at a point 50 feet south of the southeast corner of Lot Seven (7) of Block Thirteen (13) in Drake and Bartraw's Addition to the Town of Staples Mill, Todd County, Minnesota, thence running south 100 feet, thence running west approximately 124.6 feet to a point 150 feet south of the southwest corner of the above described Lot 7, thence running north 100 feet, thence running east approximately 124.6 feet to the point of beginning, and being in the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 12, Township 133 North, Range 33 West;

the corporate limits of the City of Staples are hereby extended to include the above described lands within its said limits, and the above described lands shall hereafter be included within the corporate limits of said City of Staples, and shall be a part of said City of Staples, and shall be governed as other lands and territory in said City of Staples are now governed.

Section 2. The City Clerk of the City of Staples is hereby directed to forward a certified copy of this Ordinance to the Register of Deeds of Todd County, Minnesota, and to the Secretary of State of the State of Minnesota.

Section 3. The aforesaid lands and territory shall be annexed to the City of Staples, and this ordinance shall take effect and be in full force and effect from and after its passage, approval and publication.


