

ORDINANCE NO. 140.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

Section 1. Pursuant to a petition duly signed by all the owners of the following described land abutting upon the city limits of the City of Staples, and which land has been platted in lots and blocks, and which land is described as follows, to-wit:

North Forty-three and one-half Feet (N 43½ ft.) of Lot Two (2) and South Thirty-five Feet (S 35 ft.) of Lot Three (3), all in Block One (1) of O'Connor's Addition to the City of Staples, Minnesota, according to the original plat thereof now on file and of record in the office of the Register of Deeds of Todd County, Minnesota.

the corporate limits of the City of Staples are hereby extended to include the above described lands within its said limits, and the above described lands shall hereafter be included within the corporate limits of said City of Staples, and shall be a part of said City of Staples, and shall be governed as other lands and territory in said City of Staples are now governed.

Section 2. The City Clerk of the City of Staples is hereby directed to forward a certified copy of this Ordinance to the Register of Deeds of Todd County, Minnesota, and to the Secretary of State of the State of Minnesota.

Section 3. The aforesaid lands and territory shall be annexed to the City of Staples, and this ordinance shall take effect and be in full force and effect from and after its passage, approval and publication.

The above ordinance was passed at a regular meeting of the City Council of the City of Staples on the 27th day of July, 1948.




