STIPULATION OF  
DISMISSAL

TO THE HONORABLE VICTOR H. JOHNSON, one of the Judges of the Court herein; to the Honorable Mike Holm, Secretary of State of the State of Minnesota; to the Honorable, the Legislative Body of the State of Minnesota; and to the parties herein and all others concerned:

BE IT KNOWN:

WHEREAS the contestant herein and his attorney and the contestee herein and his attorneys hereby stipulate and agree that the above entitled action and election contest filed and instituted by the contestant above named is to be, subject to the final approval of the Court, of this date dismissed with prejudice, upon the following terms and conditions:

1. That the allegations in contestants notice and complaint contained relative to violation by the contestee of The Corrupt Practices Act and the election laws of this state are dismissed, subject of course to the terms and conditions hereinafter set forth.
2. That the contestee above named, August Omtvedt, be allowed his costs and disbursements necessarily incurred in this action and these entire proceedings, as provided by law.
