

ORDINANCE NO. 197

AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE CITY OF WORTHINGTON,  
MINNESOTA.

THE CITY COUNCIL OF THE CITY OF WORTHINGTON DO ORDAIN:

NOW WHEREAS, Pursuant to Section 1043 et seq of Mason's Minnesota Statutes of 1927, being Section 413.14 of the Minnesota Statutes for 1941, all the owners of property hereinafter described and abutting upon the City of Worthington, have petitioned the City Council of said City of Worthington to have such property annexed to said City:

AND WHEREAS, It is desired that said territory become a part of said City of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, The following described territory is hereby declared to be a part of the City of Worthington; to wit,

Commencing at a point on the section line between Sections 14 and 23, Township 102 North, Range 40 West, County of Nobles and State of Minnesota, lying directly North and 189 feet West of the Northeast corner of Lot 1, Block 1, Auditor's Plat of Benson's Addition to the City of Worthington in said County and State; thence North at right angles to the North edge of Highway 16, thence continuing North 291 feet; thence West at right angles 150 feet; thence South at right angles to the said section line; thence East along said section line to the point of beginning; subject to highway easements.

and

A tract of land in the Southeast Quarter of the Southeast Quarter of Section 14, Township 102 North, Range 40 West, described as follows:

Commencing at the Southeast corner of said Section 14; thence running West on the South line of said Section 14 a distance of 179.3 feet; thence running North at right angles a distance of 196.3 feet; thence running East at right angles to the East line of said Section 14; thence running South on the East line of said section to the place of beginning, said land being in the County of Nobles and State of Minnesota; subject to highway easements.
