

ORDINANCE NO. 59

AN ORDINANCE EXTENDING THE VILLAGE BOUNDARIES

The Village Council of the Village of Foley do ordain as follows:

Section 1. That the village boundaries of the Village of Foley are hereby extended so as to include the following described parcels of land abutting upon said Village, to-wit:

A tract of land adjoining the Village of Foley in the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Twenty-six (26), Township Thirty-seven (37), Range Twenty-nine (29), described as follows:

Beginning at a point on the west line of a County Road 114.45 feet north of the intersection of such west line with the north line of Monroe Street; thence south along said west line of said County Road a distance of 114.45 feet to such intersection; thence west along the north line of said Monroe Street a distance of 392.9 feet to its intersection with the southerly line of State Trunk Highway No. 33 as recently laid out; thence northeasterly along the said southerly line of said Trunk Highway a distance of 349.5 feet; thence southeasterly a distance of 100.55 feet to the point of beginning, containing approximately three-fourths ($\frac{3}{4}$) of an acre of land, which is of record in the name of Roman H. Schaefer;

Lots Eleven (11), Twelve (12) and Thirteen (13) of Block Three (3) of Holdridge Addition to the Village of Foley, according to the plat and survey thereof on file and of record in the office of the Register of Deeds in and for said Benton County, which is of record in the names of Felix J. Latterell and Ida W. Latterell, husband and wife, as tenants in common;

Lots Eight (8), Nine (9) and Ten (10) of Block Four (4) of Holdridge Addition to the Village of Foley, according to the plat and survey thereof on file and of record in the office of the Register of Deeds in and for said Benton County, which is of record in the name of Joseph C. Grow;

Also that part of Seventh Avenue extended into said Holdridge Addition lying southerly of the extended northerly line of said Lot 8 in Block 4 of Holdridge Addition. (These portions of said lots in said Holdridge Addition and of said Seventh Avenue which lie within the limits of the former John Street which was vacated in the year 1930 are already within the village limits and are mentioned in the above matter for the purpose of the record.)
