P E T I T I O N

IN THE MATTER OF THE INCORPORATION OF WOLF

LAKE, BECKER COUNTY, MINNESOTA

TO THE HONORABLE THE COUNTY BOARD OF BECKER COUNTY, MINNESOTA:

The undersigned respectfully represent and show:

I.

That the undersigned desire to incorporate as a village, pursuant to Chapter 412 of Minnesota Statutes for 1945, that certain territory situated in the Townships of Wolf Lake and Spruce Grove, Becker County, Minnesota, described as follows, to-wit:

Blocks One (1) to Nine (9), inclusive of the Original Townsite of Wolf Lake, Minn., according to the certified plat thereof on file and record in the office of the Register of Deeds in and for Becker County, Minnesota.

II.

That said territory has been platted into lots and blocks; that a plat thereof has been duly and legally certified according to the laws of this state, and filed in the office of the Register of Deeds in and for Becker County, Minnesota.

III.

That all of said territory lies within Becker County, Minnesota, and that no part or portion thereof lies within any incorporated village or city, and that all of said territory is so conditioned as to be subject to village government.

IV.

That said territory contains a resident population of not more than three thousand persons, nor less than one hundred persons; that each of the undersigned petitioners is a qualified voter in and has resided within the territory proposed to be incorporated continuously for a period of at least two (2) years prior to the date of this petition.

V.

That an accurate census of the resident population of said territory was taken on March 1, 1949, and that the actual resident population then was, and now is, one hundred six (106) persons.

VI.

That the boundaries of the territory proposed to be incorporated are:

Parcels of land in the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section Thirty-four (34); the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Thirty-three (33), Township One Hundred Thirty-nine (139), North, Range Thirty-seven (37), West of the 5th P. M.; Lot Four (4), Section Three (3), Lot One (1) and Lot Two (2), Section Four (4), Township One Hundred Thirty-eight (138) North, Range Thirty-seven (37) West of the 5th P. M. Minnesota, described as follows:

A parcel in said Southwest Quarter of Southwest Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Thirty-four (34), beginning at southwest corner of said Section Thirty-four (34), thence north on west line said Section Thirty-four (34) (Int. Angle 88° 40' B.S. on south line said Section Thirty-four (34) distance 429 feet, thence east (Int. Angle 91° 20' distance 333 feet; thence south (Int. Angle 88° 40') Distance 429 feet, thence west (Int. Angle 91° 20') distance 333 feet on south line said Section Thirty-four (34) to point of beginning, approx. 3.28 acres.

A parcel in said SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section Thirty-three (33), Beginning at southeast corner said Section Thirty-three (33), thence north on the east section line said Section Thirty-three (33) (Int. Angle 91° 20' B.S. on south Section line said Section 33 distance 462 feet, thence west (Int. Angle 88° 40') distance 198 feet, thence south (Int. Angle 91° 20') distance 250 feet, thence southwesterly (Int. Angle 99°) distance 141.8 feet, thence (det. Angle R 6° 15') West distance 945 feet, thence south (Int. Angle 88° 41') distance 200 feet to E 1/16 corner on South line said Section Thirty-three (33), thence east on south line of said Section 33 distance 1320 feet to southeast corner said Section 33 and point of beginning. Approx. 7.26 acres.

A parcel in said Lot One (1) and Lot Two (2), Section Four (4), Beginning at northeast corner said Section Four (4), Thence West on north section line said Section Four (4) to east 1/16 corner on north section line said Section 4 (Int. Angle 100° 40') B.S. on east Section line said Section 4) distance 1320 feet, thence continuing on north section line said Section Four (4) distance 321.8 feet, thence right angle south distance 131.2 feet, thence right angle east distance 340.7 feet to 1/16 line Lot Two (2) Section Four, thence continuing east (Lot 1, Section 4) distance 884.9 feet, thence south (Int. Angle 79° 20') distance 362 feet, thence east (Int. Angle 100° 40') distance 105.5 feet thence south (Int. Angle 79° 20') distance 362 feet, thence east (Int. Angle 100° 40') distance 340 feet, thence north on east section line said Section 4 (Int. Angle 79° 20') distance 758 feet to northeast corner said Section Four (4) point of beginning. Approx. Lot 2, .999 acres, Lot 1, 9.52 acres.

A parcel in said Lot Four (4), Section Three (3), Beginning at the northwest corner Section Three (3), thence East on north section line said Section 3 (Int. Angle 79° 20') distance 366 feet, thence south (Int. Angle 100° 40') distance 363 feet, thence west (Int. Angle 79° 20') distance 366 feet to west Section line said Section 3, thence north (Int. Angle 100° 40') distance 363 feet to point of beginning, Northwest Corner said Section 3, Approx. 2.8 acres.

VII.

That the quantity of land embraced within the boundaries above described, and within the territory proposed to be incorporated, is approximately 23.859 acres, more or less, according to the government surveys thereof and on file in the office of the Register of Deeds in and for Becker County, Minnesota.

VIII.

That the name of the proposed village shall be "Wolf Lake".

WHEREFORE, the undersigned legal voters of the territory proposed for incorporation who have resided within said territory continuously for a period of at least two (2) years prior to the date of the petition respectfully pray and request that the County Board of Becker County, Minnesota, approve this petition; that it call an election for determination of the incorporation herein proposed; that it fix a time and place for holding such election; that it cause proper notice of this petition and of such election to be given; and that said board appoint three inspectors, residents of said territory, who shall act as judges of said election.
