PETITION FOR INCORPORATION OF

VILLAGE OF FRIDLEY

TO: The Board of County Commissioners of the County of Anoka, Minnesota:

THE UNDERSIGNED 25 voters, residents of the territory hereinafter described, hereby patition your honorable board to fix a time and place when and where the resident voters may vote on the proposition of incorporating such territory as a village, to be known by the name of <u>Village of Fricley</u>. The territory proposed to be incorporated is describing as follows:

That part of Township 50, Range 24, Anoka County, Minnesota, described as follows to wit: Beginning at the Northwest corner of Government Lot 2 Section 3, thence South along the Nest line thereof and the West line extended to the line between Anoke and Hennapin Counties, thence Southerly elong the dividing line between Homenin and Anoka Counties to the South Line of Anoka County, thence East along the South line of Anoka County to the Southeast corner of Section 34 of said Tornship 30, Range 24, thence North along the East line of Section 34 to the Northeast corner thereof, thence Meet along the South Line of Section 26 to the Southeast corner of the Southwest Quarter of the Southwest Quarter thereof, thence North along the East line of the West One-Fourth of said Section 26 to the Northeast corner thereof, thence East along the North line of Section 26, to the Northeast corner of said Section 26, thence North along the East line of Section 23, to the Northeast corner of the Southeast Cuarter of said Section 23, paid Tourship 30, Range 24, thence East along the North line of the South Holf of Section 24, said Tourship 30, Range 24, to the East line of said Section 24, said Tourship 30, Range 24, thence North along the East lines of Section 24, Section 13, and Section 12 to the Northeast corner of Section 12, thence West along the North lines of Section 12 and Section 11 to the Northwest corner of the Northeast Cuarter of Northwest Quarter of said Section 11, thence North along the East line of the Southwest Quarter of the Southwest Quarter of Section 2, to the Morthesst corner thereof, thence West along the North line of said Southwest Quarter of the Southwest Quarter to the Northwest corner thereof, thence continuing West along the North line of the South half of the Southeast Quarter of Section 3, and along the North line of Government Lot 2 of Section 3 to the point of beginning.

Such territory consists of lands which have been partly platted into lots and blocks, which plats have been duly and legally certified according to the laws of this state and have been filled in the office of the Register of Deeds of Anoka County, the county in which said lands lie, and the unplatted part of such territory adjoins the platted portion and is so conditioned as properly to be subjected to village government. Such territory contains 5270 acros of land and has 2016 actual residents thereon, as has been duly ascertained by a census taken under our direction on the 29th day of Jenuary, 1949, as appears by the

verification heroto. Each of the undersigned petitioners is a resident of the territory proposed to be incorporated and has been a resident thereof for more than two years preceding the signing hereof.
