On August 24, 1949, the Hibbing Village Council was served with a petition from residents of the E½ of the SE¼ of Section 24-57-21, St. Louis County, Minnesota, requesting that an election be held as provided for in Section 412.041, Subdivision 5, Minnesota Statutes Annotated, the same being Charter 110 Continuo 7, Town of 7040 for the purpose of Chapter 119, Section 7, Laws of 1949, for the purpose of ascertaining whether or not such territory should be annexed as a part of the Village of Hibbing, Minnesota.

The petition, having been properly examined and found to be in order and in conformance with law, the Village Council caused a Special Election to be held within the area in question on the 20th day of September, 1949, with the result that there were 87 votes cast, all voting in favor of such annexation.

Our Village Attorney has advised me that I must file a certified copy of the certificate of election with you, and in compliance with such instructions you will please find such certificate of election attached.
