The undersigned petitioners respectfully show to the County Board of Commissioners of Otter Tail County, Minnesota, to-wit:

Ι.

That a census has been taken of the territory hereinafter described proposed to be incorporated as a village pursuant to the laws of the State of Minnesota and that said census is attached hereto; that the same was taken by three voters residing within the area hereinafter described and the population within the limits of said territory is found to be in excess of 100 persons residing therein.

II.

That the whole of said territory proposed to be incorporated as a village is located within the County of Otter Tail and State of Minnesota and is described as follows, to-wit:
