ORDINANCE NO. 206

AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE CITY OF WORTHINGTON,
MINNESOTA.

THE CITY COUNCIL OF THE CITY OF WORTHINGTON DO OBTAIN:

NOW WHEREAS, Pursuant to Section 1843 et seq of Mason's Minnesota Statutes of 1927, being 413.14 of the Minnesota Statutes for 1941, all the owners of property hereinafter described and abutting upon the City of Worthington, have petitioned the City Council of said City of Worthington to have such property annexed to said City:

AND WHEREAS, It is desired that said territory become a part of said City of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, The following described territory is hereby declared to be a part of the City of Worthington; to-wit,

A tract of land located in the Southwest Quarter (SW $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section 14, Township 102 North, Range 40 West of the 5th P.M., County of Nobles and State of Minnesota, described as follows:

Commencing at a point on the South line of said Section 14, 1326.9 feet west of the southeast corner of said Section 14; thence northerly parallel to the east line of said Section 14, a distance of 317 feet; thence westerly parallel to the south line of said Section 14, a distance of 386.2 feet; thence southerly parallel to the easterly line of said Section 14, a distance of 317 feet to the south line of said Section 14; thence easterly along the south line of Section 14, a distance of 386.2 feet to the point of beginning.
