

An Ordinance to Annex Territory to the Village of New London  
Kandiyohi County, Minnesota.

The Village Council of the Village of New London, Kandiyohi County, Minnesota,  
do enact as follows:

That upon the petition of the majority of the property owners involved, and upon  
the certification of the Village Recorder to that effect, and upon the determining of  
the Council that annexation would be for the best interest of the Village and of the  
territory affected, the petition is hereby granted and the territory adjoining and  
abutting the Village of New London, Kandiyohi County, Minnesota, described as follows:

The Southeast Quarter of the Northeast Quarter (SE<sup>1</sup>/<sub>4</sub> of NE<sup>1</sup>/<sub>4</sub>) in  
Section 11<sup>1</sup>/<sub>2</sub> of T<sup>1</sup>/<sub>2</sub> and the North Half of the South Half of the North-  
west Quarter (N<sup>1</sup>/<sub>2</sub> of S<sup>1</sup>/<sub>2</sub> of NW<sup>1</sup>/<sub>4</sub>) in section ten (10) and the west  
66 feet of the North Half of the South Half of the Northeast Quarter,  
(W 66 feet of the N<sup>1</sup>/<sub>2</sub> of the S<sup>1</sup>/<sub>2</sub> of the NE<sup>1</sup>/<sub>4</sub>) in Section ten (10) all  
in Township one hundred twenty-one (121) Range thirty-four (34) in  
Kandiyohi County, Minnesota.

be and the same is hereby annexed to the Village of New London, Kandiyohi County,  
Minnesota, as effectively as if it had been originally a part thereof.
