

A RESOLUTION ANNEXING CERTAIN LANDS
TO THE CITY OF
MANKATO

THE COUNCIL OF THE CITY OF MANKATO, DOES HEREBY RESOLVE:

Section 1. THAT The City of Mankato, Minnesota, a municipal corporation, has under provisions of Section 413.19 of Minnesota Statutes Annotated, duly filed with the Clerk of said City a petition to have certain lands owned by it annexed to the City of Mankato.

Section 2. THAT The City of Mankato is the owner of the following tracts of land located in the County of Blue Earth, State of Minnesota, described as follows, to-wit:

North Sixty (60) acres of the Southwest Quarter (SW $\frac{1}{4}$), Section Twenty (20), Township One Hundred Eight (108), Range Twenty-six (26), excepting therefrom the following; Beginning at the NW corner of the SW $\frac{1}{4}$ of said section, thence East on the east and west $\frac{1}{2}$ line of said section 475 feet, thence South parallel with the west line of said section 205.85 feet, thence West parallel with said east and west $\frac{1}{2}$ line 181.4 feet to the West line of said Section 20, thence North on said line 387.25 feet to the point of beginning, said exception containing 3 acres more or less.

The East Half of the North West Quarter and all that portion of the North East Quarter that lies West of the Pohl Road, all in Section Twenty, Township One Hundred Eight, Range Twenty-six, containing 107 acres of land more or less, Blue Earth County, State of Minnesota.

The South 13.17 acres of the North 26.34 acres of the South West Quarter of the North West Quarter and the South 12.87 acres of the South West Quarter of the North West Quarter all in Section Twenty, Township One Hundred Eight, Range Twenty-six, Blue Earth County, State of Minnesota.

Section 3. THAT The above described tracts of land owned by the City of Mankato are not within the corporate limits of any city or village.

Section 4. THAT Said tracts of land are contiguous to and abutting upon the Southerly boundary of the City of Mankato, an incorporated city in the County of Blue Earth, State of Minnesota, having a population of not less than 10,000, nor more than 20,000, according to the last federal census.

Section 5. NOW, THEREFORE, It is resolved that said above described tracts are hereby annexed and declared to be an addition to the City of Mankato, and said Territory shall be a part of

the City of Mankato as effectually as if it had been originally a part thereof.

Section 6. THAT This Resolution shall take effect and be in force from and after its passage and publication.
