

AN ORDINANCE

An ordinance relative to the detachment of the property of Arthur G. Scullin from the Village of Lakeland Shores

The Village Council of the Village of Lakeland Shores do Ordain as follows:

Pursuant to the petition of Arthur G. Scullin requesting detachment of the following described unplatted real estate from the limits of the Village of Lakeland Shores:

Commencing at the intersection of the South line of Courtland Street in the plat of Lakeland City, according to the plat thereof on file and of record in the office of the Register of Deeds of Washington County, Minnesota, with the center line of State Highway 95; thence Easterly on the South line of said Courtland Street 700 feet to a point; thence Southerly on a line parallel to the center line of said State Highway 95, 360 feet to a point; thence Westerly and parallel to the South line of said Courtland Street to the center line of said Highway 95; thence Northerly on the center line of said Highway 95 to the point of beginning.

IT IS HEREBY ORDAINED that pursuant to Section 412.051, Minnesota Statutes Annotated, that said land and all of it be and hereby is detached from the Village of Lakeland Shores, and that said ordinance be in force immediately from and after the date hereof.
