On motion of Trustee Jorvig, seconded by Trustee Bolmgren, the following ordinance was adopted by unanimous vote of all members of the Council present:

ORDINANCE NO. 348

AN ORDINANCE PROVIDING FOR ANNEXATION
OF CERTAIN LANDS TO THE VILLAGE OF ST. LOUIS PARK

The Village Council of the Village of St. Louis Park ordains:

Section 1. The Village Council of the Village of St. Louis Park determines that a proper petition has been filed with the Council by the owners of the following described unplatted land which does not exceed 200 acres in area and which is situated within the Town of Minnetonka and is abutting on the corporate boundary of the Village of St. Louis Park and not included in any other village or in any other city or borough:

All that part of the Northeast Quarter
(NE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section
20, Township 117, Range 21, lying North of
Excelsior Boulevard.

Section 2. The Village Council hereby determines that the annexation of said land to the Village of St. Louis Park will be to the best interests of the Village and of said territory.


Section 3. The land described in Section 1 hereof is hereby declared to be annexed to the Village of St. Louis Park and to be included within the corporate boundaries of said Village, pursuant to Section 7, Chapter 119, Laws of Minnesota, 1949.

Section 4. This ordinance shall take effect from and after its publication.




