

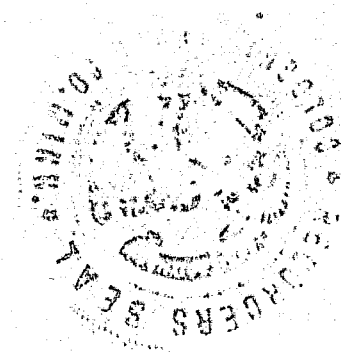

ORDINANCE #59  
AN ORDINANCE EXTENDING THE BOUNDARIES  
OF THE VILLAGE OF COLOGNE, CARVER  
COUNTY, MINN.

The Village Council of the Village of Cologne do ordain as follows:

WHEREAS, the majority of the owners of the following described tract or parcel of land situate, lying and being in Carver County, Minn., and described as follows, to-wit:

Beginning at the Northeast corner of the Northwest Quarter of the Southwest Quarter of Section 13, Township 115 North, Range 25 West which is the starting point of this description; thence West along the East and West one half section line of said Section 13 a distance of 200 feet; thence South parallel to the North and South one half Section line a distance of approximately 718 ft., to a point which is directly west from the Southerly most boundary line of the 9.55 acre tract owned by John and Genevieve Kocher in the Northwest Quarter of Southwest Quarter of Section 13 Township 115 Range 25; thence at right angle East parallel to the East and West one half Section line a distance of 1687.5 feet to a point which point is 153 feet due East of the North and South Quarter Section line; thence North to the Northeast Corner of the Benjamin Hesse Property which is described as follows, to-wit: Commencing at a point which is 25 feet North and 105 feet East from the Southwest Corner of the North half of the Northeast Quarter of Section 13, Township 115 North Range 25 West; thence North 132.5 feet; thence East 50 ft., thence South 132.5 feet; thence West 50 feet to the point of beginning; thence from the Northeast Corner of the Benjamin Hesse property, as described aforesaid, 153 feet West to the center section line of Section 13, Township 115 North Range 25 West; thence South to the center of Section 13; thence West 1334.5 feet to the point of beginning.

which said tract or parcel of land abuts upon said Village of Cologne, and contains less than 200 acres of land, have duly petitioned the Village Council of said Village of Cologne to extend the boundary of said Village so as to include said tract or parcel of land, which said petition was duly granted by said Village of Cologne, Now, Therefore, the boundaries of said Village of Cologne are hereby extended so as to include said tract or parcel of land.

This ordinance shall take effect upon its approval and publication.
