ORDINANCE NO. 161

AN ORDINANCE TO ANNEX CERTAIN ABUTTING TERRITORY TO THE VILLAGE OF HERON LAKE, MINNESOTA.

THE VILLAGE COUNCIL OF THE VILLAGE OF HERON LAKE DO ORDAIN:

NOW WHEREAS, pursuant to Section 412.041 of the Minnesota Statutes for 1941, and all amendments thereto, all of the owners of the property hereinafter described, have petitioned the Village Council of the Village of Heron Lake to have such property annexed to said City:

AND WHEREAS, it is desired that said territory become a part of said Village of Heron Lake, the same as if it had been originally a part thereof:

NOW, THEREFORE, the following described territory is hereby declared to be a part of the Villageof Heron Lake, to-wit:

Commencing at the Southwest (SW) Corner of Section Twenty (20), Township One Hundred and Four (104), North Range Thirty Seven (37), West of the 5th P. M., County of Jackson, State of Minnesota, running thence due East on the Section line thirty-five (35) feet to a point hereafter called the place of beginning; thence due North parallel to the West boundary of Section 20 a distance of Eleven-Hundred and Thirty-three (1133) feet, thence at right angles due East a distance of Three Hundred (300) feet, thence at right angles due South & distance of Eleven-Hundred and Thirty-three (1133) feet, thence at right angles due West a distance of Three Hundred (300) feet to the place of beginning.
