## ORDINANCE NO. 111

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF A PARCEL OF LAND ABUTTING THE VILLAGE OF BUHL, ST. LOUIS COUNTY, MINNESOTA.

The Village Gouncil of the Village of Buhl, Minnesota do ordain as followsy

SECTION L. That a petition has been filed with the Village Council of

Buhl, St. Louis County, Minnesota, requesting that the followingndescribed

property be annexed to and made a part of the Village of Buhl, St. Louis

County, Minnesota, to-wit;

The east six hundred fifty (650) feet of the Northwest quarter of the Southeast quarter  $(NW_{4}^{1} \text{ of } SE_{4}^{1})$  of Section Twenty (20) in Township Fifty-Eight (58) North, Range Nineteen (19) West of the Fourth Principal Meridian, according to the United States Government survey thereof, accepting, however, that portion thereof described as follows:

Assuming the east and west quarter line of said section to be due east and west, from the east one-sixteenth (I/16) corner on said line, go west two hundred fifty-five and fourteen one-hundredths (255.14) feet, to the place of beginning, thence south two degrees fifty eight minutes (2\* 58\*) one hundred eighty three (183) feet, thence west one hundred sixty-eight (168) feet, thence North two degrees fifty eight minutes (2\* 58") one hundred eighty three (183) feet, to the said east and west quarter line, thence east along said quarter line one hundred sixty-eight (168) feet to the place of beginning.

to be known as the Memorial Addition to the Village of Buhl, St. Louis County, Minnesota.

SECTION 2. That the Mayor and Village Council have given due consideration to said petition and believe that it is for the best interest of the Village of Buhl and its inhabitants that said petition be granted.

SECTION 3. It is hereby decreed, affirmed, ratified and adopted that said Memorial Addition, hereinabove described, is and shall be a part of and incorporated into the Village of Buhl effective from and after the final passage and adoption of this ordinance.

SECTION 4. Said territory is annexed to the Village of Buhl, ST. Louis County, Minnesota, pursuant to Minnesota Statutes, Section 413.14, amendatory and supplementary thereto.
