

AFFIDAVIT OF PUBLICATION

Ordinance No. 53
AN ORDINANCE ANNEXING
LANDS TO THE VILLAGE OF
ALBANY.

The village Council of the Village
of Albany do ordain as follows:

That the following described lands
to wit:

The northerly one hundred eighty
three and seven tenths (183.7) feet
of the easterly two hundred thirty
seven and one tenth (237.1) feet of
the Southwest quarter of the South-
east quarter (SW 1/4 SW 1/4) of sect-
ion Sixteen (16), Township, One
hundred twenty-five (125) N. of
Range Thirty-one (31) West, abut-
ting upon the incorporated limits of
the Village of Albany, be and the
same are hereby annexed to such vil-
lage and shall become a part of such
village as effectually as if they had
been originally a part thereof.

of November, 1950.

H. B. Harren, being duly sworn, on oath says;
that he is, and during all the time herein stated has been the publisher of the news-
paper known as THE ALBANY ENTERPRISE and has full knowledge of the facts

twenty-five per cent of its news columns have been devoted to local news of interest
to the community it purports to serve; that during all said time it has not wholly
duplicated any other publication, and has not been entirely made up of patents, plate
matter and advertisements; has been circulated in and near its said place of publica-
tion to the extent of at least two hundred and forty (240) copies regularly delivered
to paying subscribers and has entry as second class matter in its local post office; and
that there has been on file in the office of the County Auditor of Stearns County,
Minnesota, the affidavit of a person having knowledge of the facts, showing the name
and location of said newspaper and the existence of the conditions constituting its
qualifications as a legal newspaper.

That the Ordinance No. 53 hereto attached was cut from the
columns of said newspaper, and was printed and published therein in the English
language, once each week, for one successive weeks: that it was first
published on Thursday the 9th day of November 19 50;
and thereafter on Thursday of each week to and including the
