TO THE HONORABLE BOARD OF COUNTY COMMISSIONERS OF CASS COUNTY, MINNESOTA:

The undersigned voters, who have resided for a period of at least two (2) years prior to the date of this petition within the territory described in Exhibit A, hereto attached and made a part hereof, which territory is not now in any incorporated village in the State of Minnesota, and part of which has been platted into lots or blocks, or is adjacent to said platted portion, the plat of which has been duly and legally certified according to the laws of the State of Minnesota and filed in the office of the Register of Deeds in and for said County of Cass, being the county in which said lands lie, and said territory containing a resident population of not more than 3000 or less than 100, and all of which unplatted property is such as properly to be subject to village government, hereby petition your Honorable Board to call an election for the determination of a proposed incorporation of all the said territory described in Exhibit A as a village under the name of the Village of Chickamaw Beach.

Your petitioners further show that a census of the resident population residing upon and within said territory described in Exhibit A and a census list of the buildings in the area described in Exhibit A used for residences has been duly taken and that the names of the people and persons permanently residing within and upon said territory and the building in the area used for residences and the number of people living in each are set forth in Exhibit B hereto attached and made a part hereof. That said census list was taken on the 15th day of September, 1950, and that the boundaries of such territory and the quantity of land proposed to be incorporated are fully set out in Exhibit A.

BOUNDARIES OF THE PROPOSED INCORPORATED VILLAGE

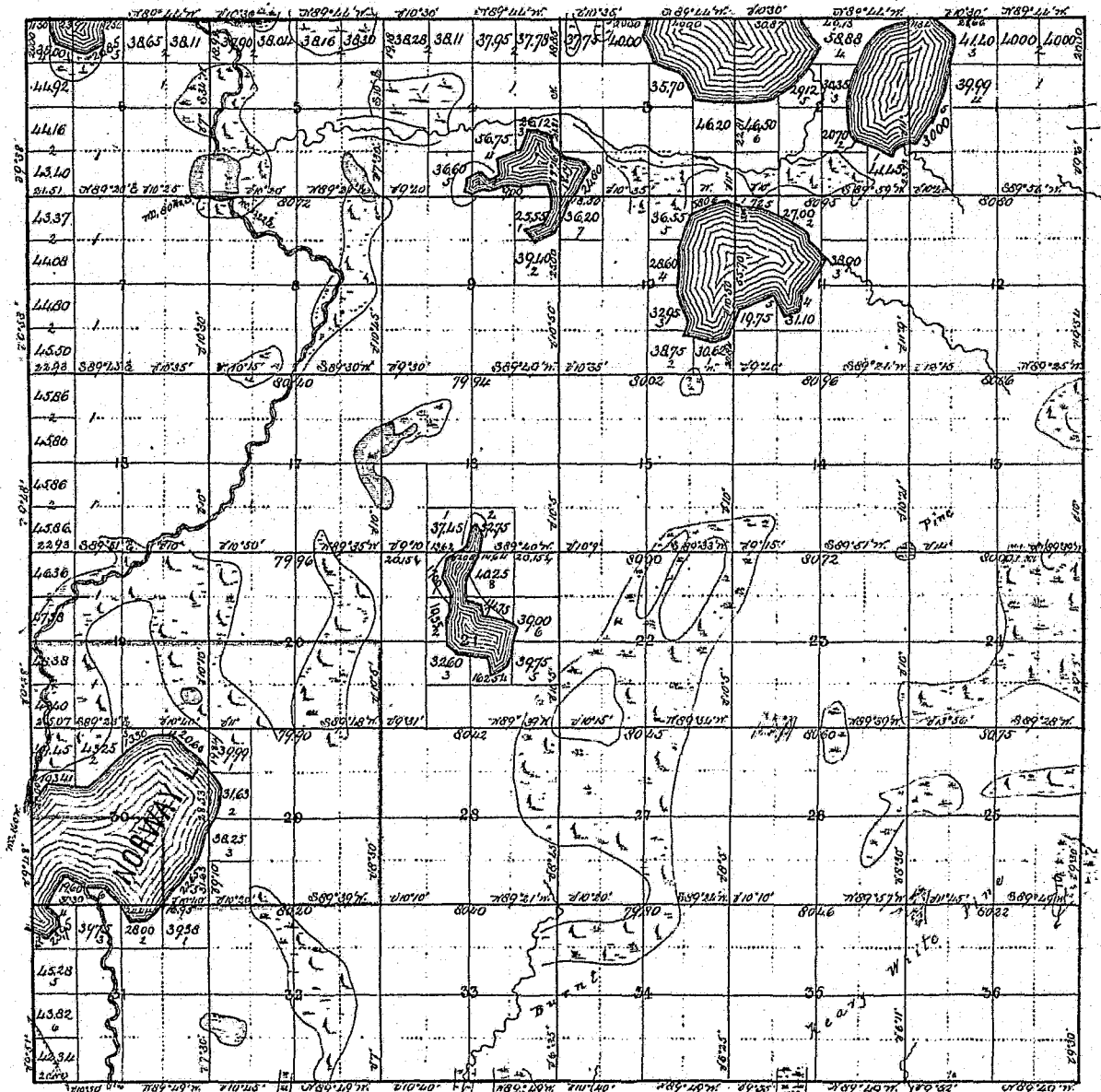
Bounded on the east by Section Twenty Eight (28) of Barclay Township and the Southwest Quarter of Section Twenty One (21) of Barclay Township; bounded on the North by the North Half ($N\frac{1}{2}$) of Section Twenty (20) and the North Half ($N\frac{1}{2}$) of Section Nineteen (19) ^{lying east of Pine River,} Barclay Township; bounded on the West by the Pine River as far south as Norway Lake to the Northwest corner of the Southwest Quarter ($SW\frac{1}{4}$) of Section Thirty (30); thence easterly and bounded on the South by the Southwest Quarter ($SW\frac{1}{4}$) of Section Thirty (30) and the Northwest Quarter of the Southeast Quarter ($NW\frac{1}{4}$ of $SE\frac{1}{4}$) of Section Thirty (30); thence Southerly and bounded on the West by the West Half ($W\frac{1}{2}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section Thirty (30); thence easterly bounded on the South by the Northeast Quarter of the Northeast Quarter ($NE\frac{1}{4}$ of $NE\frac{1}{4}$), of Section Thirty One (31) and of the North Half ($N\frac{1}{2}$) of Section Thirty Two (32). Said proposed incorporated village including the following territory:

All of Section Twenty Nine (29); the South Half ($S\frac{1}{2}$) of Sections Twenty (20) and Nineteen (19), except that part thereof West of said Pine River; all of Section Thirty (30) excepting that part thereof West of the Pine River and excepting that lying in the Southwest Quarter ($SW\frac{1}{4}$) of said Section Thirty (30); and the West Half ($W\frac{1}{2}$) of the Southeast Quarter ($SE\frac{1}{4}$) of said Section Thirty (30), all in Barclay Township One Hundred Thirty Eight (138), Range Twenty Nine (29), Cass County, Minnesota.

Total area consisting of 2060 acres more or less as per attached map made a part hereof.
