

ORDINANCE No. 115

An Ordinance Annexing to the Village of Waverly
of Wright County, Minnesota, Territory Abutting
Thereon

The Council of the Village of Waverly of Wright County, Minn-
esota, Do ordain:

A.

The village council do find,

1. That those certain premises situate in the state of Minnesota,
county of Wright described as follows, to-wit:

Lot 8 of block 1 of Bremer's Addition, Wright County,
Minnesota, according to the plat thereof on file and of
record in the office of the Register of Deeds, Wright
County, Minnesota; that said Bremer's Addition being lo-
cated in section 32, township 119 north and range 26 west;

abutt on the village of Waverly of Wright County, Minnesota.

2. That said premises are not included in any other village or
in any city or borough.

3. That said premises are so conditioned as properly to be sub-
jected to village government.

4. That said land is platted and does not exceed two hundred acres.

5. That the owners thereof have duly petitioned the said village
council to have such land included within the village.

6. That the council does hereby determine that the annexation of
said land to the village of Waverly will be to the best interests
of the village of Waverly and of the said premises.

7. That said petition is signed by all of the owners of the land
so proposed to be annexed.

B.

Now therefore, be it further ordained, that said premises
be and they hereby are annexed to the village of Waverly and they
shall^{and}/thereupon do constitute a part of the village of Waverly
of Wright County, Minnesota. Let the Clerk of said village file
a certified copy hereof with the County Auditor of Wright County
and with the Secretary of the state of Minnesota and thereupon
such annexation shall be complete and the land shall be a part

of the village as effectually as if it had been originally a part.

C.

This ordinance shall take effect and be in force from and after passage and publication.
