

ORDINANCE NO. _____

AN ORDINANCE AMENDING ORDINANCE NO. 100
VILLAGE OF CRYSTAL

THE VILLAGE COUNCIL OF THE VILLAGE OF CRYSTAL DOETH:

Section 1. All of the owners of the land hereinafter described, having petitioned the Village Council to have said land included within the Village of Crystal, and it appearing that said property sits on the Village of Crystal; that it is not included in any other village or in any city or township; that it is so situated as to be properly subjected to village government; that said land is unoccupied and does not exceed two-hundred (200) acres; and the Village Council having determined that the annexation of said property will be in the best interests of the Village and of the territory affected, it is hereby ordered that

The North one-half of the northwest quarter of the Northwest quarter and all of the Southwest quarter of the Northwest quarter, all in Section Five (5), Township 118, Range 21, according to the Government survey thereof,

be and the same is hereby annexed to the Village of Crystal.

Section 2. A certified copy of the Petition filed in the Clerk's office and this Ordinance shall be filed by him in the office of the County Auditor of Hennepin County, Minnesota, and another certified copy of said Petition and Ordinance shall be filed by him in the office of the Secretary of State.

Section 3. This ordinance shall be in full force and effect from and after its passage ~~and publication~~, and the filing of the certified copies of the documents as required by law.
