AN ORDINANCE TO EXTEND THE EDUNPARIES OF THE VILLAGE OF NORWOOD AND INCORPORATE ADDITIONAL TERRITORY THEREIN.

The Village Council of Norwood, Minnesota do ordain:

the territorial limits of the Village are hereby extended to include such land within its limits, which shall hereafter be governed as other territory of the Village is governed.


