



AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF NORWOOD AND INCORPORATE ADDITIONAL TERRITORY THEREIN.

The Village Council of Norwood, Minnesota do ordain:

Section 1. Village Boundaries Extended. Pursuant to a Petition

duly signed by the owners of the land described as follows:

The West 33 feet of the following described property or tract or parcel of land:

Commencing at a point which point is 33 feet south; thence 237.14 feet East of the Southwest corner of the Northwest Quarter of the Southwest Quarter (SW Cor. of NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section 14, Township 115, Range 26; thence running South 367.4 feet; thence East 555.71 feet; thence North 367.4 feet; thence West 555.71 feet to the place of beginning; Excepting therefrom a tract of land described as follows: Commencing at a point which point is 33 feet South; thence 342.85 feet East of the Southwest corner of the Northwest Quarter of Southwest Quarter (SW Cor. of NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section 14, Township 115, Range 26; thence running South 65 feet; thence East 75 feet; thence North 65 feet; thence West 75 feet to place of beginning.

the territorial limits of the Village are hereby extended to include such land within its limits, which shall hereafter be governed as other territory of the Village is governed.

Section 2. Copy to be filed with Secretary of State and with County Auditor.

The Village Clerk shall forward a certified copy of this ordinance to the Secretary of State and to the County Auditor.

Section 3. Effect. Such land shall be annexed upon the filing of the certified copies hereof with the Secretary of State and County Auditor.
