

ORDINANCE NO. 81

AN ORDINANCE RELATING TO THE ANNEXATION TO THE VILLAGE
OF PARCELS OF THE EAST 175 FEET OF OUTLOT 20 IN THE
SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 5,
TOWNSHIP 115 NORTH, RANGE 35 WEST, DEWELLE COUNTY, MINNESOTA

THE VILLAGE COUNCIL OF DANUBE, MINNESOTA DO ORDAIN AS FOLLOWS:

Section I

The land presently owned solely by William G. Mueller and Adeline Mueller, husband and wife, as joint tenants, situated in Dewelle County, Minnesota and described as the East 175 Feet of Outlot Twenty (20) in the southwest quarter (SW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Five (5), Township One Hundred Fifteen (115) North, Range Thirty-five (35) West, the West 27 Feet of said Outlot 20 having been in the Village limits, is hereby annexed to said Village and made a part thereof pursuant to the petition of the owners of such land which has this date been granted by the Council.

Section II

This ordinance shall take effect and be in full force and effect from and after its passage and publication, according to law.

Section III

A certified copy of this ordinance shall be filed in the office of the County auditor of said County and another certified copy of this ordinance shall be filed in the office of the Secretary of the State of Minnesota, according to law.
