

ORDINANCE NO. 153

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF STAPLES AND INCORPORATING  
ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

Section 1. Pursuant to a petition duly signed by all of the owners of all of the lots in the east half of Block Three (3) in Brannon Addition to Staples, in the west half of Block Nineteen (19) in O'Connor's Addition to Staples, and in the east half of Block One (1) of Bohne's Addition to Staples, which petition has been duly filed in the office of the City Clerk of the City of Staples, which lands have been platted into lots and blocks and which lands abut upon and are adjacent to the City of Staples, Todd County, Minnesota, and in which petition said petitioners did petition that the City Council do and perform all things necessary to accomplish the annexation of said premises to and within the City of Staples in accordance with the provisions of the laws of the State of Minnesota and the charter of the City of Staples, and which lands and premises are more particularly described as follows:

Lots Four (4), Five (5) and Six (6) of Block Three (3) of Brannon Addition to Staples,

and

Lots One (1), Two (2), Three (3), Four (4) and Five (5) of Block One (1) of Bohne's Addition to Staples,

and

Lots One (1), Two (2), Three (3), Four (4), Five (5) and Six (6) of Block Nineteen (19) of O'Connor's Addition to Staples,

the corporate limits of said City of Staples are hereby extended to include the above described lands within its limits and the above described lands shall hereafter be included within the corporate limits of said City of Staples and shall be a part of said City of Staples, and shall be governed as other lands and territory in said City of Staples are now governed. In order to include the above described premises within the corporate limits of the City of Staples, the corporate limits are changed and from and after the passage of this ordinance said corporate limits shall be described as follows:

Commencing at the intersection of the center line of the alley running north and south in Block Three (3) of Brannon Addition to Staples with the north line of Lot Three (3) of said Block Three (3) extended, as the limits are now described in Ordinance No. 133 passed by the City Council of the City of Staples on August 28, 1945, thence extending north along the center line of said alley to the north line of Lot Five (5) of Block One (1) of Bohne's Addition to Staples, thence east along the north line of said Lot Five (5) of Block One (1) of Bohne's Addition to Staples to the center line of Third Street, thence south along the center line of Third Street to the intersection of the center line of Third Street with the center line of Park Avenue as the said streets are now laid out and platted, thence east along the center line of Park Avenue to the intersection of the center line of Park Avenue with the center line of the alley running north and south in Block Nineteen (19) in O'Connor's Addition to Staples, thence south along the center line of said alley in said Block 19 to the intersection of said center line of said alley with the center line of Pleasant Avenue as the same is now laid out, and there connecting with the corporate limits of said City of Staples as the same now are.

Section 2. The City Clerk of the City of Staples is hereby directed to forward a certified copy of this ordinance to the Register of Deeds of Todd County, Minnesota and to the Secretary of State of the State of Minnesota.

Section 3. The aforesaid lands and territory shall be annexed to the City of Staples, and this ordinance shall take effect and be in full force and effect from and after its passage, approval and publication.

The above ordinance was passed at a regular adjourned meeting of the City Council of the City of Staples on the 11th day of July, 1951.




