2 AN ORDINANCE ANNEXING LAND TO THE VILLAGE OF WAVERLY

3 The Village Council of the Village of Waverly of Wright
4 County, Minnesota, ordains:

5 I.

6 That those certain premises situate in the State of Minnesota,
7 County of Wright described as follows, to-wit:

8 Lots 4, 5, 6, 7 and 9 of block 1; Lots 1, 2 and 3 of Block 2;
9 Block "A"; Lots 1, 2, 3 and 10 of block 1; of Bremer's Addit-
10 ion of Wright County, Minnesota, according to the plat thereof
11 on file and of record in the office of the Register of Deeds
12 of Wright County, Minnesota, which Bremer's Addition is located
13 in section 32, township 119 north, range 26 west;

14 abutt upon the Village of Waverly of Wright County, Minnesota;
15 that they are not included in any other village, nor city, nor
16 borough; that said premises are so conditioned as properly to be
17 subjected to village government as a part of the Village of Wav-
18 erly; that all of the owners of said land, or persons having in-
19 terest therein, either inchoate or otherwise, or any part thereof,
20 are: Henry Bremer, Helen W. Bremer, Wilhelmina E. Doerfler,
21 George J. Doerfler, Frederick E. Bremer, Jerome L. Cullen and
22 Lois E. Cullen; that no other persons have any interests or owner-
23 ship in said real estate. That said premises consist of twelve
24 lots together with an entire block to-wit: said block "A", all
25 consisting of now developing or potential residential area, that
26 may properly be integrated with the village of Waverly for all use
27 and occupation and for governmental purposes. That said owners
28 have filed a petition with the Village Council of said village to
29 have said land included within said Village of Waverly; and they
30 are the sole owners, occupants, and residents of said premises,
31 together with the included streets. That said land is duly platted
32 and the plat thereof duly approved by the County Board of the
County of Wright and State of Minnesota; that it is for the best
interests of the village of Waverly and of said premises and the
persons interested therein that the same, together with the in-
cluded streets, be annexed to the Village of Waverly, of Wright
County, Minnesota; and the same hereby are so annexed.

Let the Village Clerk cause due publication hereof to be made
and a certified copy of this ordinance to be filed in the office
of the County Auditor of Wright County, Minnesota, and another
certified copy of this ordinance to be filed in the office of the
Secretary of State of Minnesota, and said land shall be a part of
the Village as effectually as if it had been originally a part
thereof.
