The Village Council of the Village of Caverly of Wright County, Minnesota, ordains:

That those certain premises situate in the State of Minnesota, County of Wright described as follows, to-wite

Lots 4, 5, 0, 7 and 9 of block 1; Lots 1, 2 and 3 of Block 2; Block "A"; Lots 1, 2, 3 and 10 of block 1; of Gremer's Addition of Gright County, Minnesota, according to the plat thereof on file and of record in the office of the Register of Deeds of Wright County, Minnesots, which Bremer's Addition is located in section 32, township 119 north, range 26 west;

abutt upon the Village of Maverly of Mright County, Minzesota; that they are not included in any other village, nor city, nor borough; that said premises are so conditioned as properly to be subjected to village government as a part of the Village of May-orly; that all of the owners of said land, or persons having interest therein, either incheste or otherwise, or any part thereof, are: Genry Bremer, Helen H.
