ORDINANCE NO. 65

An Ordinance Declaring Certain
Real Estate Annexed to the Village
of Morgan

The Village Council of the Village of Morgan does Ordain:

That the following described real estate lying and being in Redwood County, Minnesota, which said real estate ~~which said real estate~~ abuts on said village, is owned by said village in fee and is not included in any other city, village or borough, to wit:

A tract or parcel of land commencing at the Southeast Corner of the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Fifteen (15), Township One Hundred Eleven (111), Range Thirty-four (34) and running thence West along the South line of the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section Fifteen (15) a distance of seven hundred ninety and eight-tenths (790.8) feet to the easterly corner of Lot Four (4) of Block Eighteen (18) of the Second Addition to the Village of Morgan, thence Northeasterly a distance of one hundred forty and three-tenths (140.3) feet along the Southeasterly line of said Lot Four (4) produced in a Northeasterly direction, thence North a distance of two hundred ninety-six and seven-tenths (296.7) feet, thence East a distance of six hundred ninety and three-tenths (693.3) feet to the east line of the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of said Section Fifteen (15), thence South along the East line of said Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of said Section Fifteen (15) a distance of three hundred ninety-nine (399) feet to the place of beginning, containing 6.46 acres, more or less,

be, and is hereby, annexed to the Village of Morgan in Redwood County, Minnesota.
