

**ORDINANCE NO. 27  
VILLAGE OF KIESTER**

The Village Council of the Village of Kiester ordains:

1. WHEREAS A petition has been duly filed with the Village Clerk of the Village of Kiester praying that the following described lands and premises situated in the Township of Kiester in said Faribault County, Minnesota, to wit:

The East Five Hundred Feet of that part of the Southwest Quarter of Section Twenty-one (21) in Township One Hundred One (101) North of Range Twenty-four (24) West of the Fifth Principal Meridian that lies North and East of the Right of Way of the Chicago and Northwestern Railway Company, as the same is now located over and across the said Southwest Quarter of Section Twenty-one (21) aforesaid;

be annexed to the Village of Kiester, and

2. WHEREAS Said lands and premises are unplatted and do not exceed two hundred (200) acres in area, and that said petition has been signed by all of the owners of the lands hereinbefore described, and

WHEREAS The Village Council of the Village of Kiester has determined that the annexation of said lands and premises hereinbefore described will be for the best interests of the Village of Kiester and of the land and premises herein described.

NOW THEREFORE, BE IT ORDAINED By the Village Council of the Village of Kiester, as follows:

A. That the following described lands and premises, to wit: The East Five Hundred Feet of that part of the Southwest Quarter of Section Twenty-one (21) in Township One Hundred One (101) North of Range Twenty-four (24) West of the Fifth Principal Meridian that lies North and East of the right of way of the Chicago and Northwestern Railway Company, as the same is now located over and across the said Southwest Quarter of Section Twenty-one (21) aforesaid;



ORDINANCE NO. 27  
VILLAGE OF KIESTER

The Village Council of the Village of Kiester ordains:

1. WHEREAS A petition has been duly filed with the Village Clerk of the Village of Kiester praying that the following described lands and premises situated in the Township of Kiester in said Faribault County, Minnesota, to wit:

The East Five Hundred Feet of that part of the Southwest Quarter of Section Twenty-one (21) in Township One Hundred One (101) North of Range Twenty-four (24) West of the Fifth Principal Meridian that lies North and East of the Right of Way of the Chicago and Northwestern Railway Company, as the same is now located over and across the said Southwest Quarter of Section Twenty-one (21) aforesaid;

be annexed to the Village of Kiester, and

2. WHEREAS Said lands and premises are unplatted and do not exceed two hundred (200) acres in area, and that said petition has been signed by all of the owners of the lands hereinbefore described, and

WHEREAS The Village Council of the Village of Kiester has determined that the annexation of said lands and premises hereinbefore described will be for the best interests of the Village of Kiester and of the land and premises herein described.

NOW THEREFORE, BE IT ORDAINED By the Village Council of the Village of Kiester, as follows:

A. That the following described lands and premises, to wit: The East Five Hundred Feet of that part of the Southwest Quarter of Section Twenty-one (21) in Township One Hundred One (101) North of Range Twenty-four (24) West of the Fifth Principal Meridian that lies North and East of the right of way of the Chicago and Northwestern Railway Company, as the same is now located over and across the said Southwest Quarter of Section Twenty-one (21) aforesaid;

be annexed to the Village of Kiester, and that from and after the passage and publication of this ordinance said lands and premises shall be a part of said Village of Kiester.

B. That said lands and premises hereinbefore described be and the same are hereby designated as Baker-Boettcher Addition to the Village of Kiester.

3. That this ordinance shall be in effect from and after its passage and publication as required by law.
