An Ordinance Annexing Certain Land in Division Number Four (4) of St. Paul Park to the Village of St. Paul Park.

THE VILLAGE COUNCIL OF THE VILLAGE OF ST. PAUL PARK DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by the owner of that certain tract of land containing less than two hundred acres, abutting upon the Village of St. Paul Park, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said Village, and it being determined that the land hereinafter described is so conditioned as properly to be subjected to Village Government, and it being further determined that the best interests of the Village and of said land will be effected by annexation thereof to said Village.

Now, therefore, pursuant to Section 412.041 of the Minnesota Statutes Annotated, the following described tract of land lying and being in the County of Washington, State of Minnesota, to-wit:

Lots One (1) through Thirty (30), all numbers inclusive, Block One Hundred Nineteen (119) of Division Number Four (4) to St. Paul Park, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said Washington County;

be, and the same is hereby annexed to the Village of St. Paul Park, so as to be included in said Village as effectually as if the same had originally been a part of said Village.

Section 2. Upon the filing of a certified copy thereof in the office of the County Auditor of said Washington County, and further upon the filing of another certified copy of this Ordinance in the office of the Secretary of the State of Minnesota, and from and after its publication, this ordinance shall take effect and be in force.
