Ordinance No. 17

AN ORDINANCE TO ANNEX TO THE VILLAGE OF MEDICINE LAKE, MINNESOTA  
CERTAIN TERRITORY ABUTTING ON SAID VILLAGE:

THE VILLAGE COUNCIL OF THE VILLAGE OF MEDICINE LAKE, HENNEPIN  
COUNTY, MINNESOTA, DO ordain as follows:

The following described unplatted land in Hennepin County,  
Minnesota, to-wit:

That part of the Northwest Quarter of the Northwest Quarter  
of Section thirty-six (36), Township One Hundred Eighteen (118),  
Range Twenty-two (22), described as follows:

Commencing at the intersection of the West line of  
Medicine Lake Road and the South line of Electric Short Line  
Railway, thence West along said Railway a distance of 50 rods;  
thence South parallel with the West line of said Northwest  
Quarter a distance of 16 rods; thence East at right angles  
to the West line of Medicine Lake Road; thence North along  
said road to the point of beginning, and

The East 825 feet of the North four (4) rods of the Northwest  
Quarter of the Northwest Quarter in Section Thirty-six (36),  
Township One Hundred Eighteen (118), Range Twenty-two (22),

be and the same hereby is declared to be annexed to the Village  
of Medicine Lake, Hennepin County, Minnesota.

Upon the filing of a certified copy of this ordinance in the  
office of the County Auditor of Hennepin County, Minnesota and in  
the office of the Secretary of State for the State of Minnesota,  
the annexation shall be complete and the land shall become part of  
the Village of Medicine Lake, Hennepin County, Minnesota as effectual  
as if it had been originally a part of said village.
