JUDGMENT

JUDGMENT

This cause, having been regularly placed on the calendar of the above named court for the January, 1950, General Term thereof, came on for trial before the court without a jury, upon issues made by the parties. And the court, after hearing the evidence adduced at the trial and being fully advised in the premises, did on the 21st day of April, 1950, duly make and file its finding of fact, conclusions of law, and order for judgment therein.

Now therefore, pursuant to said order and on motion of Palmer & Rice, by Robert Rice, Attorneys for the Petitioner, it is hereby adjudged and decreed that the land described below to, and the same is hereby detached from the corporate limits of the Village of Holland. The land to be detached from the Village of Holland is described as follows:

The Southeast Quarter (SE^{1/4}) of Section 12 and all that part of the South Half (S^{1/2}) of the Northeast Quarter (NE^{1/4}) of Section 12 lying south of and adjoining the town of Holland and additions, and east of the right of way of the Miller and Sioux Falls Railroad as same is now located over and across said S^{1/2} of NE^{1/4}, excepting from said premises, however, that certain tract of land sold to Robert Martens #2, and now ~~hereinafter~~ described as follows: to-wit: Commencing at a point 60 feet south and 104 feet west of the northeast corner, Lot 15, Block 1, South Addition to the Town of Holland; thence south 200 feet; thence west 200 feet; thence north 200 feet; thence east 200 feet to the place of beginning. Also excepting from said premises, however, a strip of land 316 feet wide south of and adjoining Rock Street and extending from Carter Avenue eastward to the east line of said Section 12 and also excepting from the said premises, however, a certain tract of land described as follows: to-wit: Commencing at a point 60 feet south and 104 feet west of the southeast corner of Block 2, of the South Addition to the Town of Holland, thence west 75 feet; thence south 200 feet; thence east 75 feet; thence north 200 feet to the place of beginning. All the above being in Township 107, Range 15 West of the 6th P. M., excepting also therefrom however, a three tracts of land doctored by the Travelers Insurance Co. to Peter A. Baartman in the following conveyances: (1) Deed dated April 20, 1942, recorded in Book 137 of Deeds, page 243 in the office of the Register of Deeds of Pipestone County, Minnesota. (2) Deed dated April 1, 1943, recorded in Book 137 of Deeds, page 354 in the office of the Register of Deeds of Pipestone County, Minnesota. (3) Deed dated January 6, 1943, and conveying that part of the above described premises as follows: to-wit: Beginning at a point 910.2 feet south, 39° 12' W. west of the southwest corner of Lot 11, Block 2, South Addition of the Village of Holland, Minnesota;

thence south 30° 00' min. east a distance of 2165 feet; thence
south 37° 22' min. west a distance of 1670 feet; thence north 30°
min. a distance of 60 feet; thence north 37° 12' min. east a
distance of 3040 feet to the point of beginning. Said tract
containing 0.12 acre, more or less.


