

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That I, STANLEY L. BRINK of MURRAY county, state of MINNESOTA, now being in the army of the United States, do hereby constitute and appoint IONA MURPHY BRINK my wife, who is also of the above residence, my true and lawful attorney in fact, for me, and in my name, place and stead, to act for me and represent my interests, and I hereby authorize the said IONA MURPHY BRINK for me and in my stead and name, to sell, transfer, lease, convey, contract for, purchase, acquire possession, collect and receive money, enter into agreements, represent my interest, execute any instruments in writing including the drawing and endorsing of checks, execution of deeds and mortgages, and to transact any and all business in connection with any property, real, personal, or mixed, tangible or intangible, owned by me now or acquired or inherited by me in the future. She may execute and deliver vouchers in my behalf for any and all allowances and reimbursements properly payable to me by the United States, including but not restricted to allowances and reimbursements for transportation of dependents or for shipment of household effects as authorized by law and army regulations. She may take possession, and order the removal and shipment, of any of my property from any post, warehouse, depot, dock, or any other place of storage or safekeeping, governmental or private; and to execute and deliver any release, voucher, receipt, shipping ticket, certificate, or other instrument necessary or convenient for such purpose.

If I should be reported or listed, either officially or otherwise, as "missing in action" as that phrase is used in military parlance, it is the intentment hereof that such status designation shall not bar my attorney from fully and completely exercising and continuing to exercise any and all powers and rights herein granted, and that such report of "missing in action" shall neither constitute or be interpreted as constituting notice of my death nor operate to revoke this instrument.

I hereby ratify any and all lawful things and acts done or to be done by said attorney in fact in the execution of the powers and rights authorized herein.

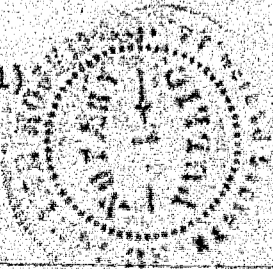
